<b>Reason:</b> Metrc and the State of Louisiana are providing additional guidance to the industry on what information is required in notes for Waste package adjustments.								

Greetings Metrc Users,

Metrc, in conjunction with the Louisiana Department of Agriculture and Forestry (LDAF), is providing guidance on what is required within the notes when utilizing packages adjustments for waste. Currently the notes field is required, but to ensure full transparency reporting to LDAF, certain requirements will need to be included in the notes field when recording waste for a package.

## Package Adjustments for Waste Notes

When the user has identified a package that includes material that will be wasted out. They should highlight the package and select Adjust.

This will prompt an action window where the user will indicate the amount of product that is being removed from the package, and the reason for the adjustment. In this case, it will be "Waste". This selection will require a freeform note field be submitted with the adjustment. The LDAF and Metrc are providing notice that going forward in this note field, the user should be recording the following: **Reason for waste, destruction method, and material mixed with the waste to render it unusable**. Upon completing the required information, the user selects "Adjust Packages" to complete the action.
