Reason: Metrc and the CCC are providing additional guidance around the Ingredient and CBD Content							

Greetings Metrc Users,

On **January 8<sup>th</sup>, 2021** the Cannabis Control Commission (CCC) enacted changes within the Metrc system that requires additional item information to be entered when creating any new items in Metrc. These changes were outlined and explained in **Metrc Bulletin #35**.

The purpose of this bulletin is to provide additional guidance to the industry on the use of the ingredients and potency fields, and what to enter into these required fields in the case an item does not have any ingredients or CBD content.

The CCC has indicated that the following entries are acceptable for item requirements

- 1. If no CBD is present in an item, the value input in the Unit CBD Content field should be **0.0001 mg**
- 2. If an item does not have any additional ingredients, the value input in the Ingredients field should be "**None**"

## **Additional Item Requirement Guidance**

As stated in Bulletin 35, the CCC now requires several new fields of item information to be entered into Metrc. These requirements included **Unit CBD Content** and **Ingredients**. If a field is required in the Metrc system, in order to create the item there must be a value entered in each field. The CCC is indicating that the following entries can be used by the industry for items that do not have CBD or additional Ingredients:

- 1. If no CBD is present in an item, the value input in the Unit CBD Content field should be **0.0001 mg.**
- 2. If an item does not have any additional ingredients, the value input in the Ingredients field should be "**None**"
