Greetings Metrc Users,

The DPHHS and Metrc previously released Bulletin 14 and 15 providing details into the Patient Status Lookup feature to support the monthly calendar limit tracking. At this time, we are implementing some additional features to Help accurately track purchasing limits per MT statute.

The functionality being implemented for the Patient Status Lookup is multi limit tracking for patient purchasing limits and equivalencies. Previously, the system tracked monthly sales only. The new functionality will begin to track limits on a daily basis in addition to the existing monthly tracking.. Starting on **October 1st, 2020** Providers will be required to lookup both daily and monthly patient limits prior to executing a sale.

Metrc has also provided support through the Application Programming Interface (API) for Third Party Integrators (TPIs) to verify a Patient's Active/Inactive status along with their total multiple purchasing limits. Metrc also released API Bulletin 80 to notify vendors of the update.

Multi Limit Tracking Update

Starting on **October 1st, 2020** Providers will now see that patients have two purchasing limits with equivalencies based on Flower and THC allotments that align with the calendar and daily tracking limits for each patient.

Additional information on these equivalencies and limits were outlined within Bulletin 14. As a reminder DPHHS requires all Providers are recording their sales transactions into Metrc in real time.

Users with the ability to conduct sales will need to ensure they are granted the appropriate permission by the Metrc admin, or an employee who can edit employee permissions at their facility.

The permission will be found within the "Search Menu" for "Dispensaries" only.



Once the permission is granted to a user, the patient status lookup will be the magnifying glass in the top right-hand side of the toolbar.



When selecting the magnifying glass, you will be prompted to a patient lookup that will be the same as the example below.

Each patient will now have both a daily and monthly limit associated for their allowable purchase amounts that will be reflected within the Purchase Amount Days. The monthly calendar limit that users have seen will stay consistent as before and reset at the first of the month. The daily limit will reflect upon the patient's purchases within the operating hours of a business day.

Key points about the patient lookup:

- Patients will be designated with either a Valid/Inactive/Expired Registration Status. A sale **should never** occur to a Patient who is expired or inactive.
- A sale should never occur to a person who is not found within the patient lookup function.
- Within the patient status lookup, providers **will not** be able to see the purchase details or previous purchase locations of the patient. Providers will only be able to view the total amount of product purchased to date.
- The calendar limit setting will always have the purchase amount days set at 31 due to it being the longest month(s) during the year. There will continue to be a background update to reset on the 1st of the month regardless off the Purchase Amount Days.
- The Purchase Amount Days set at .5 will reflect the patient purchases within a 12 hour period that encompasses normal business hours
- Flower Allowed, Flower Purchased, and Flower Available will designate the Medical Marijuana Flower amounts. This will capture all items recognized as Marijuana Flower or Marijuana Concentrate Equivalency that are being sold.
- THC Allowed, THC Purchased, and THC Available will designate the Medical Marijuana Infused amounts. This will capture all items recognized as Marijuana Infused Products that are being sold.
- Patient's numbers must be **entered exactly as they appear** on their card and the sale **must be** recorded immediately upon purchase.
