Greetings Metrc Users,

Metrc is pleased to provide information on new resources that will be available to the industry for Metrc Support and Training. The bulletin is split between the two new resources, <u>Metrc Learn</u> and the <u>Metrc Knowledge Center</u>.

Metrc Learn is an interactive learning management system, that allows users to complete modular training for multiple areas of Metrc. The system will teach the user specific functionality and processes, allow the user to demonstrate, and test the user on the information provided. Users will even be able to export and share their completed trainings.

The Metrc Knowledge Center is a portal that provides users on-demand access to various resource materials including past bulletins and helpful links. This center is designed to be a supplemental resource to the Metrc Support team, providing options for self-assistance with documentation, a live-chat feature, and the ability to submit support tickets directly to our team.

## Metrc Learn – An Interactive Learning Management System

Metrc Learn is designed to provide users with skills on the functionality available within Metrc they need to use the system effectively. Metrc Learn is organized into role-specific programs that are made up of various courses; each course is focused on one function in Metrc. For example, the Cultivator program might include 15 courses, such as "Creating an Immature Plant Batch," "Tracking Additives," "Reporting Waste," etc.

At this time, Metrc Learn offers four programs—Cultivator, Manufacturer, Sales, Testing—and 42 courses. Additional programs and courses are currently under development.

To access Metrc Learn, the user will register their account (<u>Metrc Learning Registration</u>), and upon approval of Metrc status, will be sent an email invitation to set their password. If a user is working in multiple states or licenses, you should register for the program that reflects the area of your role you are looking to have additional training on first. This registration page is shown below in **Figure 1**.

**Please Note:** Users are encouraged use an email they will have access to regardless of business association for their registration to ensure that any training transcripts are still accessible if email access is no longer available.

Course trainings are interactive and iterative to reinforce learnings and ensure knowledge retention. Each course includes a demo and a hands-on component. The demo visually walks



users through each step of the process and includes guidance via pop-up windows and voice narration. An example is shown below in **Figure 2**.

After viewing the demo, users get to try it themselves. As they step through the process on their own, they receive prompts and guidance if they make any errors. They can review the demo and try it themselves <u>as many times as they'd like</u>. This feature can is shown below in **Figure 3**.

Users can either self-select or be assigned programs and can take each course at their own pace. This approach gives users the flexibility to learn about other areas of the system that may interest them, as well as the ability to see what courses are mandatory for their role. Once they complete all courses in a program, they take a comprehensive quiz, which they must pass (scoring 70% or higher) before the program is considered complete.

Metrc Learn tracks and displays all completed coursework. You will even have opportunities to receive badges and certificates upon completion of a program. And, if they want, they can print out a transcript of all their trainings for record keeping and ongoing training exercises.

### Export Transcripts

## Metrc Knowledge Center

The Metrc Knowledge Center is designed to provide licensees the ability to search and view Metrc related content. The knowledge center is a repository for information that Metrc Support would normally help them obtain. This includes Bulletins, helpful links and, in the future, best practices and common questions.

For example, if a user was looking for a certain bulletin, they can enter the bulletin number or key words in the search bar to find all the relevant documentation.

The search feature is located at the top of the page along with a link to Metrc.com and below that our contact information and hours. Below this section they will see a button for their state that will take them to their repository. This can be seen in below in **Figure 6**.

Once a bulletin has been selected, it will take you to the bulletin page. The user can view the bulletin by clicking on it again, print the bulletin, share the bulletin, or follow to stay on top of any updates made to this bulletin. At the bottom, the user can indicate if the article was helpful to provide feedback on the documentation. This page is shown below in **Figure 8**.

### Zendesk Answer Bot

The Answer bot is located in Metrc Support response emails to refer them over to the knowledge center. It is an AI function that learns as it is used by the industry. It ties into the knowledge center information only. Should the licensee need additional help at any time, they can utilize chat with support, have a phone call with support or send an email.

### Live Chat




Figure 12: Live Chat Feature

Live chat is another feature available through the Knowledge Center. This feature allows licensees to chat with the agents live. To access this feature, the user will click the icon and this will prompt an action window to begin chatting with an agent. The chat feature will ask some basic questions like their full name and phone number and give that information to the agent. This is shown in **Figure 12**, below.

### How to Access

Metrc Portal is the access to the Metrc Knowledge Center for the licensees to login and see their own individual tickets. The user will be able to see the interactions between themselves and the agent.

The user can navigate to the portal login screen by using the link located under the support drop down in the Metrc user interface or by navigating directly to the webpage at support.metrc.com. This screen is shown below in **Figure 13**.
