Metrc is pleased to provide information on our newest enhancements within the software. These enhancements, fixes, or document updates include:

- I. Restricting Multi-Destination Transfer Manifests to Display only the Destination License Viewing the Manifest
- II. Added Source Harvest Field to the Transfer Grid and Manifest

# **Multi-Destination Transfer Manifests**

Metrc users have the ability to view manifests for transfers they are receiving once created by the shipping license. Shipping licenses can create multi-destination transfers if the transporter is completing multiple transfers in a single trip. Now receiving license users will only see the license they are viewing the manifest under as a destination.

To create a multi-destination transfer, the user at the shipping facility will create the transfer and use the blue "+" button to add multiple destinations. This button is shown below in **Figure 1**.

This button will trigger the additional destinations to the transfer action window and the user will enter all the required information for the second destination. Once complete, the user will utilize the green "Register Transfer" button to complete the process. This step is demonstrated below in **Figure 2**.

Once the transfer is registered, the users will be able to view the manifests that are outgoing and incoming to the facility.

**Please Note:** At receiving facilities of a multi-destination transfer, the user will only be able to view the entry for the transfer incoming to the facility under which the manifest was viewed.



## Source Harvest Field for Transfers

Metrc has added the source harvest field of packages being transferred so they can be viewed within the transfer drill down and the transfer manifest. To view the source harvest of a package in a transfer, the user would navigate to their licensed transfer screen and drilling down on transfer, then the destination to view the package information which now displays the source harvest. This is shown below in **Figure 3**.
