Greetings Metrc® Users,

To ensure all industry users are compliant with OMMA’s statewide seed-to-sale tracking system prior to the May 26 deadline, OMMA and Metrc will be hosting free educational sessions, both in-person and online, May 3-6, 2022. *These training sessions are optional, but highly recommended to ensure all users are trained on the Metrc system.*

Training sessions will be offered for Grower, Processor, Dispensary, and Transporter/Waste Disposal Facility users.

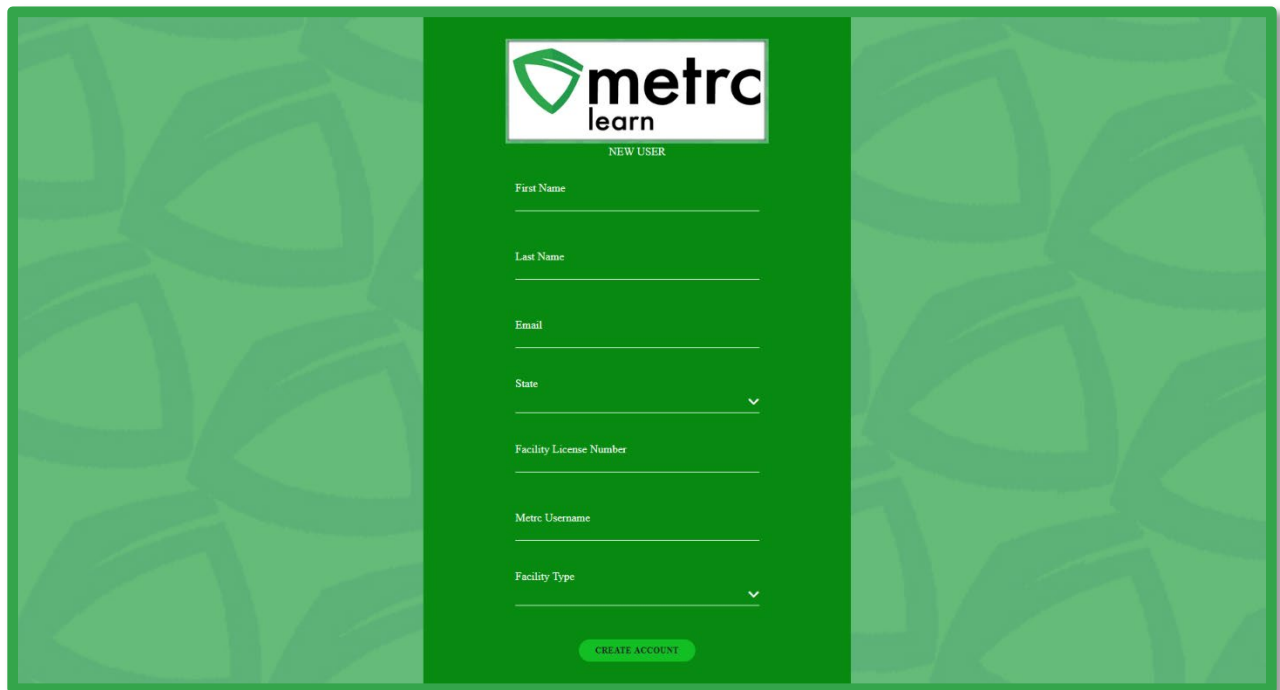
Register for Metrc Learn – An Interactive Learning Management System

Metrc Learn is designed to provide users with skills on the functionality available within Metrc needed to use the system effectively and similar to the New Business and Advanced Trainings. Metrc Learn is organized into role-specific programs that are made up of various courses, with each course being focused on one function in Metrc. For example, the Grower, or Cultivator, program might include different courses, such as “Creating an Immature Plant Batch,” “Tracking Additives,” “Reporting Waste,” etc.

At this time, we will facilitate the registration for the upcoming May 2022 Live Trainings through the Metrc Learn tool as shown below. **Note:** These are separate registrations.

To access Metrc Learn, the user will register their account ([Metrc Learning Registration](#)). You can enter your “Agent Registration Number” in place of the “Facility License Number”. Upon approval of Metrc status, you will be sent an email invitation to set your password. If a user is working in multiple licenses, you should register for the program that reflects the area of the role you are looking to have additional training on first. 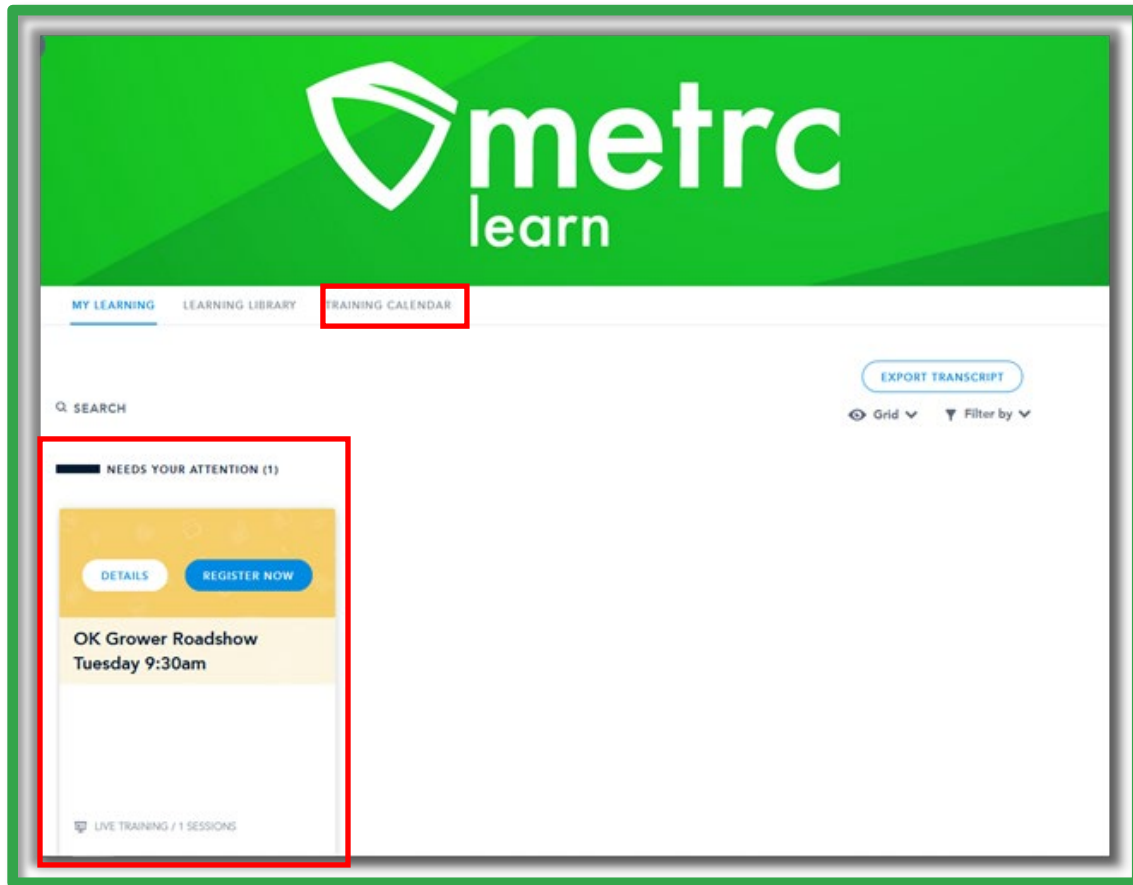


Figure 2: Metrc Learn Registration Dashboard

After selecting the desired session, you will be taken to the following screens to confirm registration for the desired training as shown below:

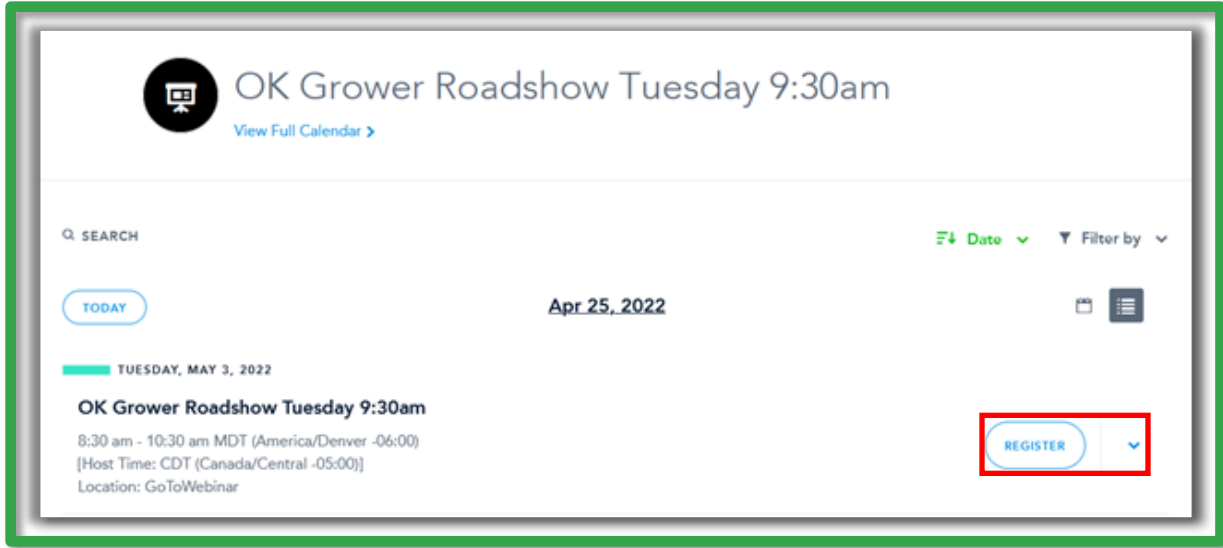


Figure 3: Register for In-Person Training Session

After clicking “Register” for the desired training session you will receive an e-mail from Notifications@metrclearn.bridgeapp with the prompt to complete registration. This is shown below:

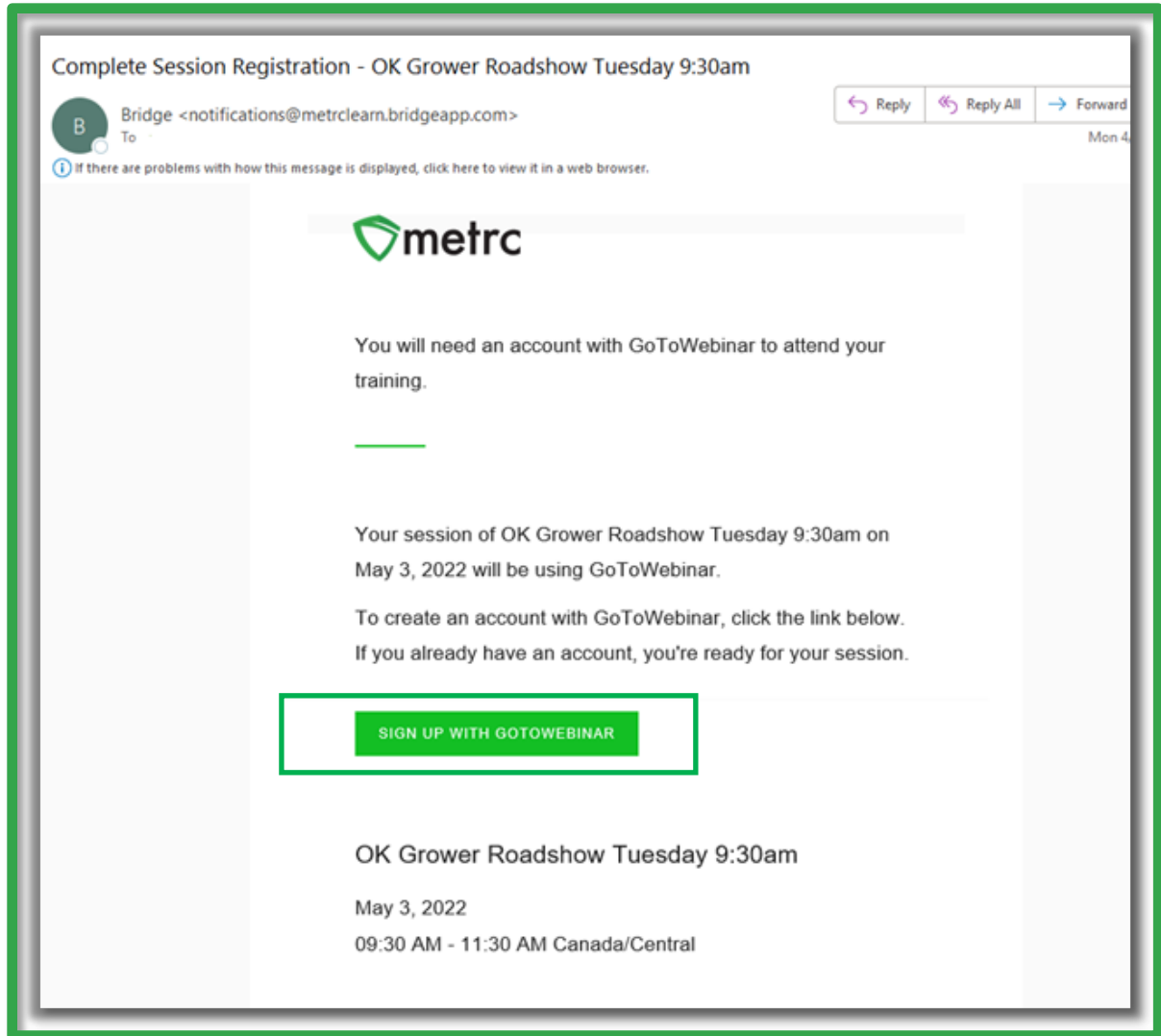
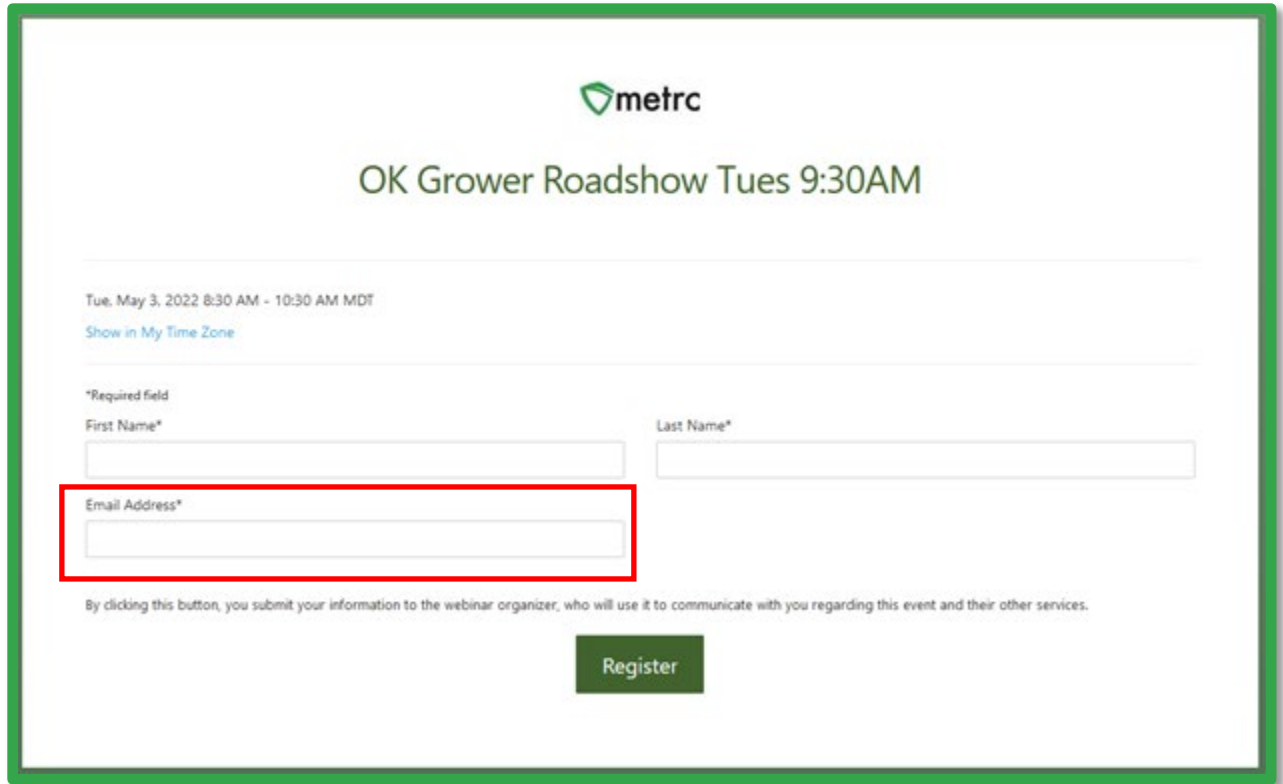


Figure 4: Register for OK Training from e-mail prompt
