Greetings Metrc Users,

The purpose of this bulletin is to share an important update regarding upcoming licensing changes for recreational facilities and to provide guidance regarding transfers.

### **License Number Changes**

#### Important Update:

#### This change has been postponed until September 1st, 2018

All Recreational Cannabis facilities (Cultivators, Manufacturers, and Stores) will experience a change of their facility license numbers.

Recreational facilities currently have a 10-digit license number with a 6-digit suffix; this 10-digit license number will be *replaced* with a **brand new** 20-digit license number.

#### EXAMPLE:

*Current Recreational License Number:* 1234567890-001-CUL *New Recreational License Number:* 12345678901234567890

The changes to your license numbers will go into effect on the day of implementation and will immediately be registered in Metrc.

These changes should not affect any of your day-to-day reporting in Metrc and you will be able to log in as normal. Upon logging in, you will see your new license number at the top right corner of your screen.

It is critical that all system Admins verify the license number change on the day it occurs and instruct staff to begin using the new license number.



### License Number Changes – RFID Tags

Following this change, all recreational facilities will be registered under the new license numbers in Metrc and the MED licensing systems. Many organizations will still have tags that list the old facility license number to use up before placing a new tag order.

#### Things to Know:

On September 1st, all licensed recreational facilities will be listed in Metrc under their new 20-digit license numbers.

On September 1st, all new RFID tag orders will automatically list your new 20-digit facility license number.

All your facility information in Metrc will be the same as it was EXCEPT the license number.

#### All recreational facilities will be able to use up any remaining RFID Plant/Package tags.

You may choose to void any of your tags with the old facility license numbers and proceed with the new tags once received.

#### Things to Do:

Please notify all your staff members, especially inventory control personnel, of the expected changes.

Please notify your vendors/clients if you do wholesale transactions to avoid any confusion.

#### **Recommendations and Best Practices:**

We recommend that licensees use up all remaining tags with the original license numbers before using any new tags.

We recommend posting a notice to all staff members who may be affected that identifies what the old license number was and what the new number is until all the old tags have filtered out of the facility and the change has been fully implemented.

Put your new facility license number(s) on a business card for your customers/vendors.



### License Number Changes – Voiding RFID Tags

You may choose to void any unused tags in Metrc under the "Admin" tab.

Any "Voided" tags should be destroyed.

## "Virtual Transfers"

Licensees may not, at any time, perform a "Virtual Transfer" on their own for any reason.

All licensees should be verifying the weight/count of all Packages BEFORE they are received in Metrc. \*If Packages on a transfer manifest are not accurate, they should be rejected.

If an error is discovered **BEFORE** a transfer departs the shipping facility, the manifest should be edited or voided.

If an error is discovered **DURING** a transfer, all affected Packages should be rejected by the recipient. \*If the recipient does not want to reject Packages, they may adjust the weight/quantity of the affected Packages after receiving them. This will not excuse missing/inaccurate inventory.

Any variance in Packages MUST be documented.

If an error is discovered **AFTER** a transfer has been received, contact the MED for guidance.
