Greetings Metric® Users, this bulletin is intended to notify all industry users of the planned upcoming Metric In-Person and Live Webinar Workshop training this coming **August 22nd – 25th, 2022** for the State of Nevada’s CCB. Below you will find key highlights and more information on how to register for the upcoming workshop through our new on-demand training tool called [Metric Learn](#).

- Due to the events involving COVID-19, all scheduled classes were provided via webinar. However, this upcoming Metric Live Webinar Workshop will have some in-person sessions. Each user, or attendee, is required to register for the class they want to attend through [Metric Learn](#). (Link below)
- In accordance with instructions from the State of Nevada CCB; beginning in 2020, all persons that actively work in Metric must attend the Workshop Live Webinar training at least once a year. All other agent card holders that work in, or manage, a marijuana establishment must attend the mandatory training at least once every 2 years.
- Each attendee will be required to complete and pass a test on the topics discussed.

***Please note:** You must register for Metric Learn first. After receiving a confirmation e-mail from Metric, you **MUST THEN** register for the NV workshop following the prompts below.

Register for Metrc Learn – An Interactive Learning Management System

Metrc Learn is designed to provide users with skills on the functionality available within Metrc. Users will need to use the system effectively, similar to the New Business and Advanced Metrc Trainings. Metrc Learn is organized into role-specific programs that are made up of various courses; each course is focused on one function in Metrc. For example, the Cultivator program might include different courses, such as “Creating an Immature Plant Batch,” “Tracking Additives,” “Reporting Waste,” etc.

At this time, we are facilitating the registration for the upcoming August 2022 Workshop through the Metrc Learn tool as shown below. Please note that this is a separate registration from your Metrc account.




Figure 1: Metrc Learn Registration Page

To access Metrc Learn, the user must register their account (link to [Metrc Learning Registration](#)). You can enter your “Agent Registration Number” in place of the “Facility License Number”. Upon approval of Metrc status, you will be sent an email invitation to set your password. If a user is working in multiple licenses, you should register for the program that reflects the area of the role you are looking to have additional training on first. This registration page is shown below in **Figure 1**.

Please Note: Users are encouraged to use an email they will have access to regardless of business association for their registration to ensure that any training transcripts are still accessible if email access is no longer available.

Register for NV August Workshops 2022

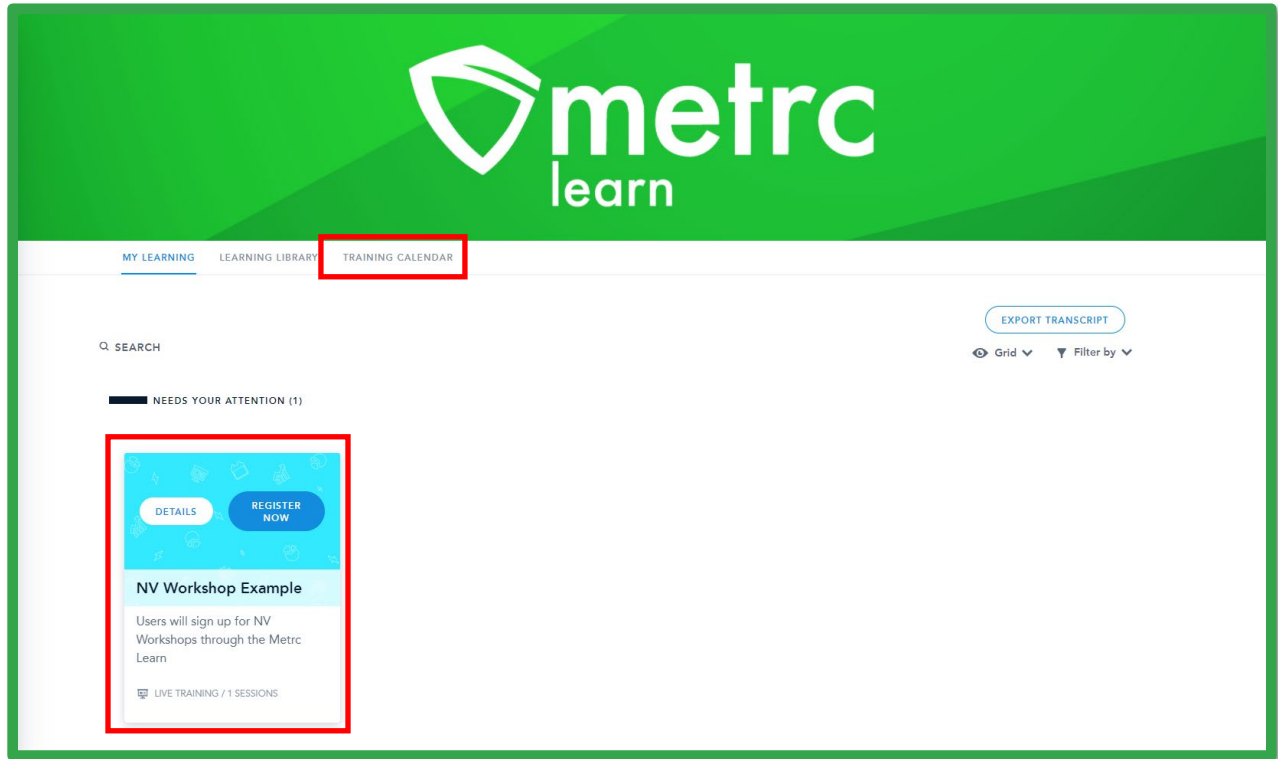


Figure 2: Metrc Learn Registration Dashboard

Once you have access to Metrc Learn you will be directed to the Dashboard shown below and will have the “**NV August Workshop 2022**” module available. Alternatively, you can register for the workshop by heading over to the “**Training Calendar**” tab as shown below in **Figure 2**.

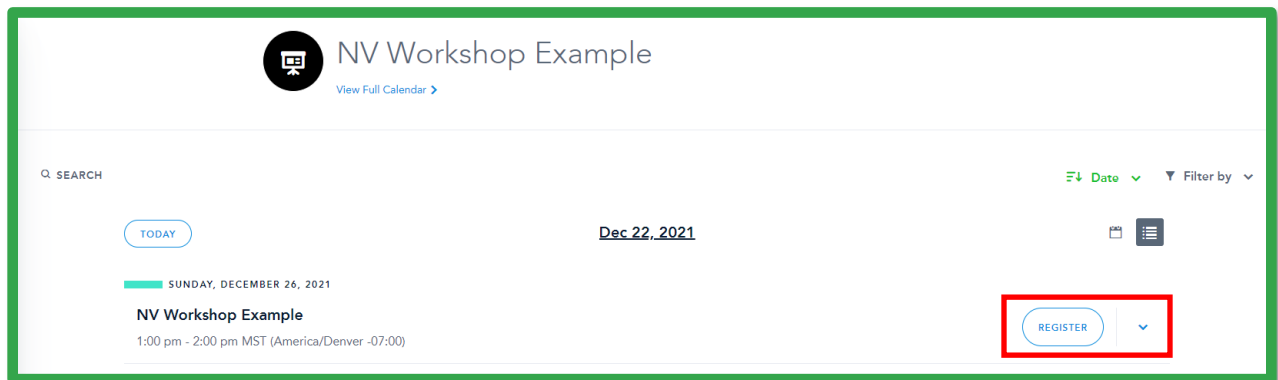


Figure 3: Register for “NV August Workshop 2022”

After selecting the “**NV August Workshop 2022**” module, you will be taken to the following screens in order to confirm registration for the desired workshop (as shown in **Figure 3**).

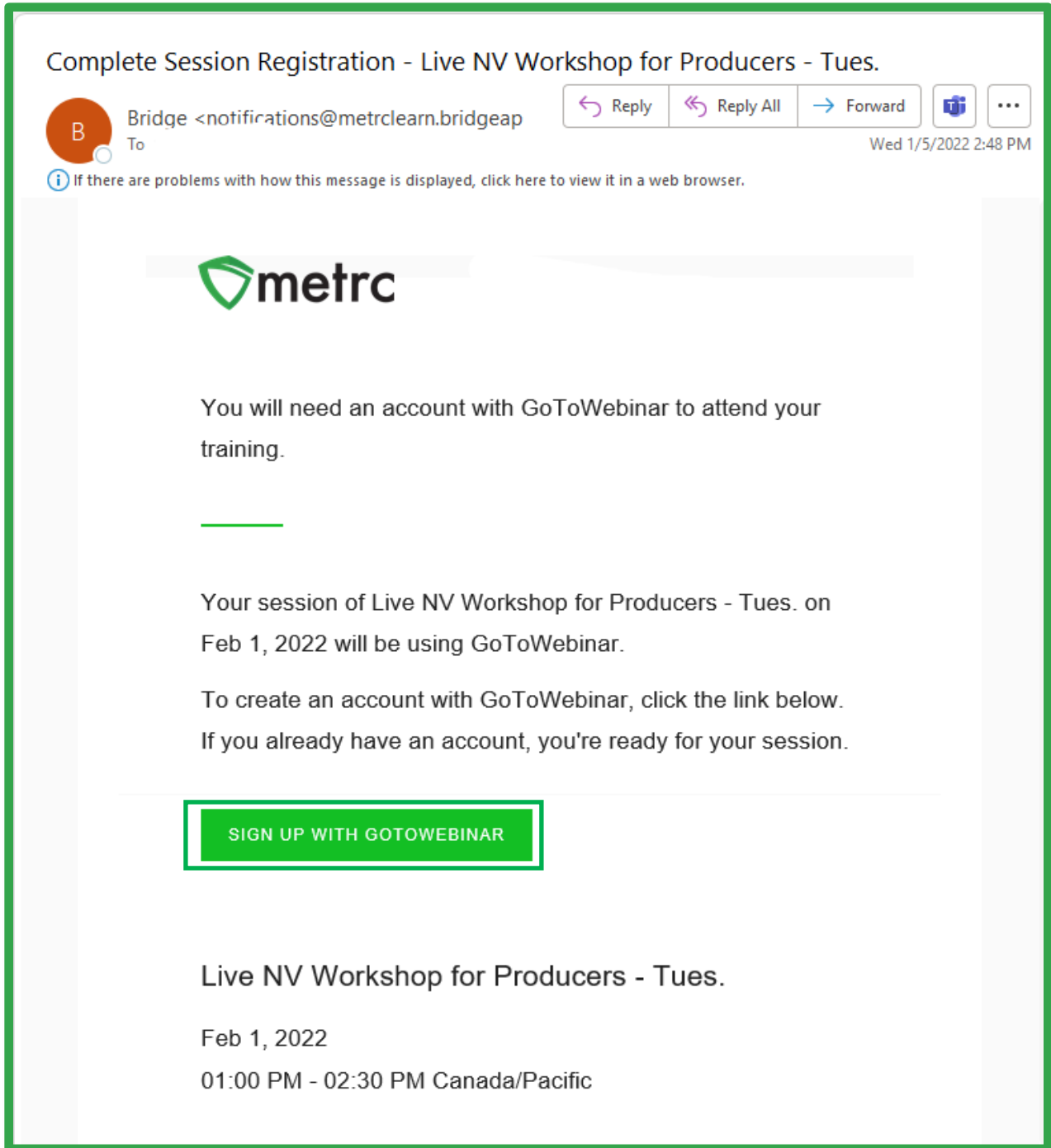



Figure 4: Register for “NV August Workshop 2022” from e-mail prompt

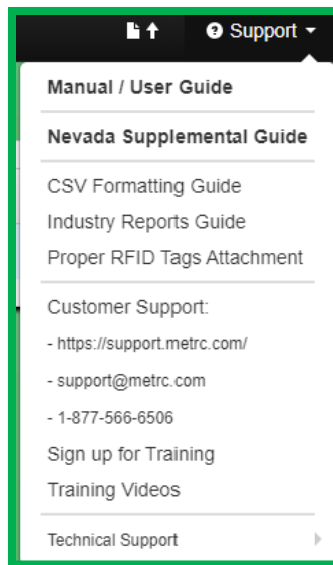
