2. Proprietary Rights

(a) No Implied Conveyance of Proprietary Rights. You acknowledge that the Licensed Software represent and will continue to represent the valuable, confidential and proprietary property of Metrc and, where applicable, its suppliers. Specifically, You acknowledges that aspects of the Licensed Software and associated documentation, including the specific design and structure of individual programs, may be protected by Metrc's patent, copyright, trademark, service mark, trade secret,
