## Source Harvest Tab

Metrc has added a new tab within the packages drilldown for users to view information on a source harvest(s) that contributed to the creation of the package. This information includes the license that created the harvest, harvest name, and date of the harvest. This will also allow you to view all the harvest information for packages created from multiple harvests.

To view this information, you will drill down on the package details and select the "Source Harvests" tab. This is shown in **Figure 3** below.

## Lab Test Batch Package Details

Metrc has added a new tab under within the packages drilldown to provide users more concise information on the lab test batches for which the package was tested. To view this new tab, you can drill down into the package details using the carrot on the far-left side of the package entry, and select the "Lab Test Batches" tab. The information provided will be the lab test batch name, the number of test types performed and required, and the pass/fail status of the results.

If you would like to view the individual tests performed under the test batch, you can drill down on each one to see the results. **Figure 4** is an example of how this information is displayed.
