Reason: Metrc is providing details for in-person and online industry user training classes.		

Greetings Metrc® Users, this bulletin is intended to notify all industry users of the planned upcoming Metrc Hybrid Workshop training February 27- March 2, 2023, for the State of Nevada CCB. Below you will find key highlights and more information on how to register for the upcoming workshop through our new on-demand training tool called Metrc Learn.

- There will be a 100-person limit for the in-person training classes. If you’re interested in attending in person, then you will need to contact support to confirm availability and registration via email at support@metrc.com.
- All the scheduled classes will also be provided via webinar, and each user will be required to register for the class they want to attend online through [Metrc Learn](#). (Link below)
- In accordance with instructions from the State of Nevada CCB; starting in the year 2023, Metrc training requirements are as follow:
 - One-time facility specific training for all employees, facility managers, managing owners, officers, and board members.
 - Annual advanced training for inventory managers, employees, facility manager, supervisors, directors and managing owners **with access to the seed to sale tracking system.**
- Each attendee will be required to complete and pass a test on the topics discussed.

Please Note: You must register for Metrc Learn first, and after receiving a confirmation e-mail from Metrc, you **MUST** then register for the NV workshop following the prompts below.

Register for Metrc Learn – An Interactive Learning Management System

Metrc Learn is designed to provide users with skills on the functionality available within Metrc they need to use the system effectively similar to the New Business and Advanced Trainings. Metrc Learn is organized into role-specific programs that are made up of various courses; each course is focused on one function in Metrc. For example, the Cultivator program might include different courses, such as “Creating an Immature Plant Batch,” “Tracking Additives,” “Reporting Waste,” etc.

At this time, we will facilitate the registration for the upcoming February 2023 Workshop through the Metrc Learn tool as shown below. Note these are separate registrations




Figure 1: Metrc Learn Registration Page

To access Metrc Learn, the user will register their account ([Metrc Learning Registration](#)). You can enter your “Agent Registration Number” in place of the “Facility License Number” Upon approval of Metrc status, you will be sent an email invitation to set your password. If a user is working in multiple licenses, you should register for the program that reflects the area of the role you are looking to have additional training on first. This registration page is shown below in **Figure 1**.

Please Note: Users are encouraged to use an email they will have access to regardless of business association for their registration to ensure that any training transcripts are still accessible if email access is no longer available.

Register for NV February Workshops 2023

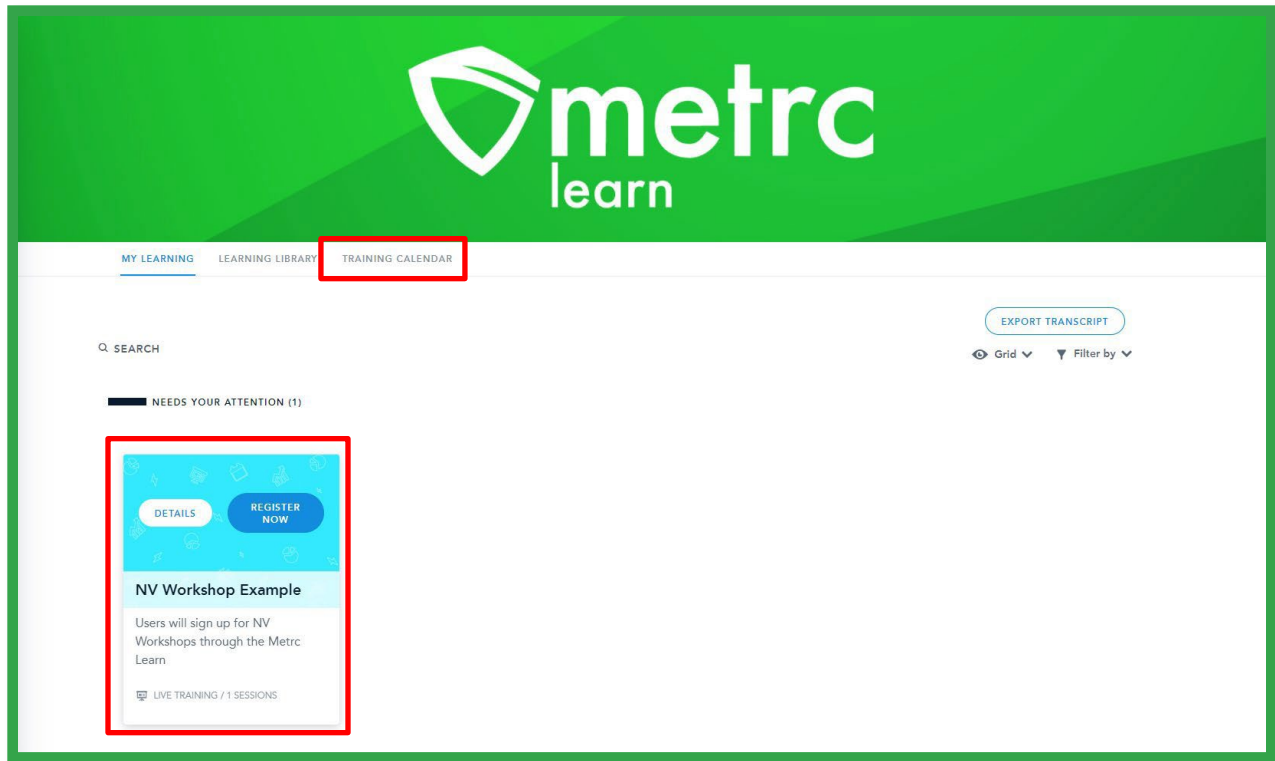


Figure 2: Metrc Learn Registration Dashboard

Once you have access to Metrc Learn you will be directed to the Dashboard shown below and will have the “NV February Workshops 2023” module available. Alternatively, you can register for the workshop by heading over to the “Training Calendar” tab as shown below in **Figure 2**.

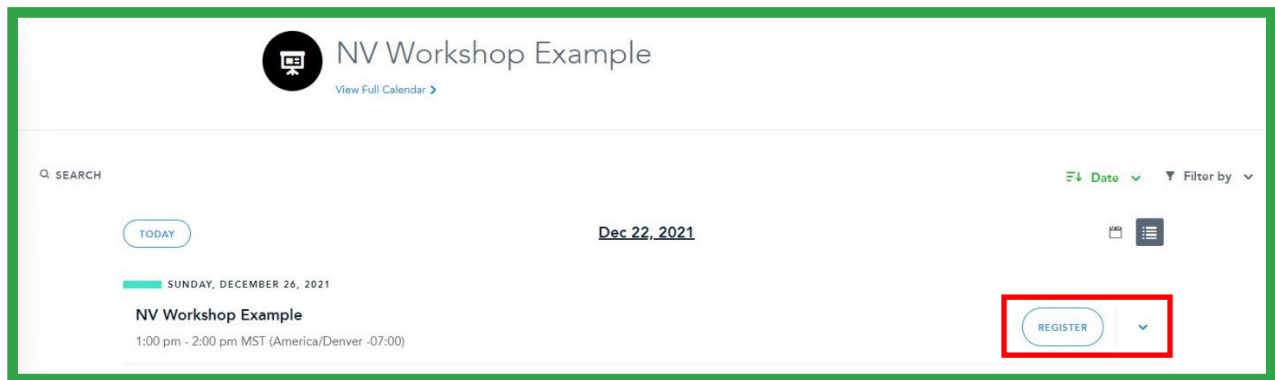


Figure 3: Register for “NV February Workshops 2023”

After selecting the “NV February Workshops 2023” module you will be taken to the following screens in order to confirm registration for the desired workshop as shown in **Figure 3**.

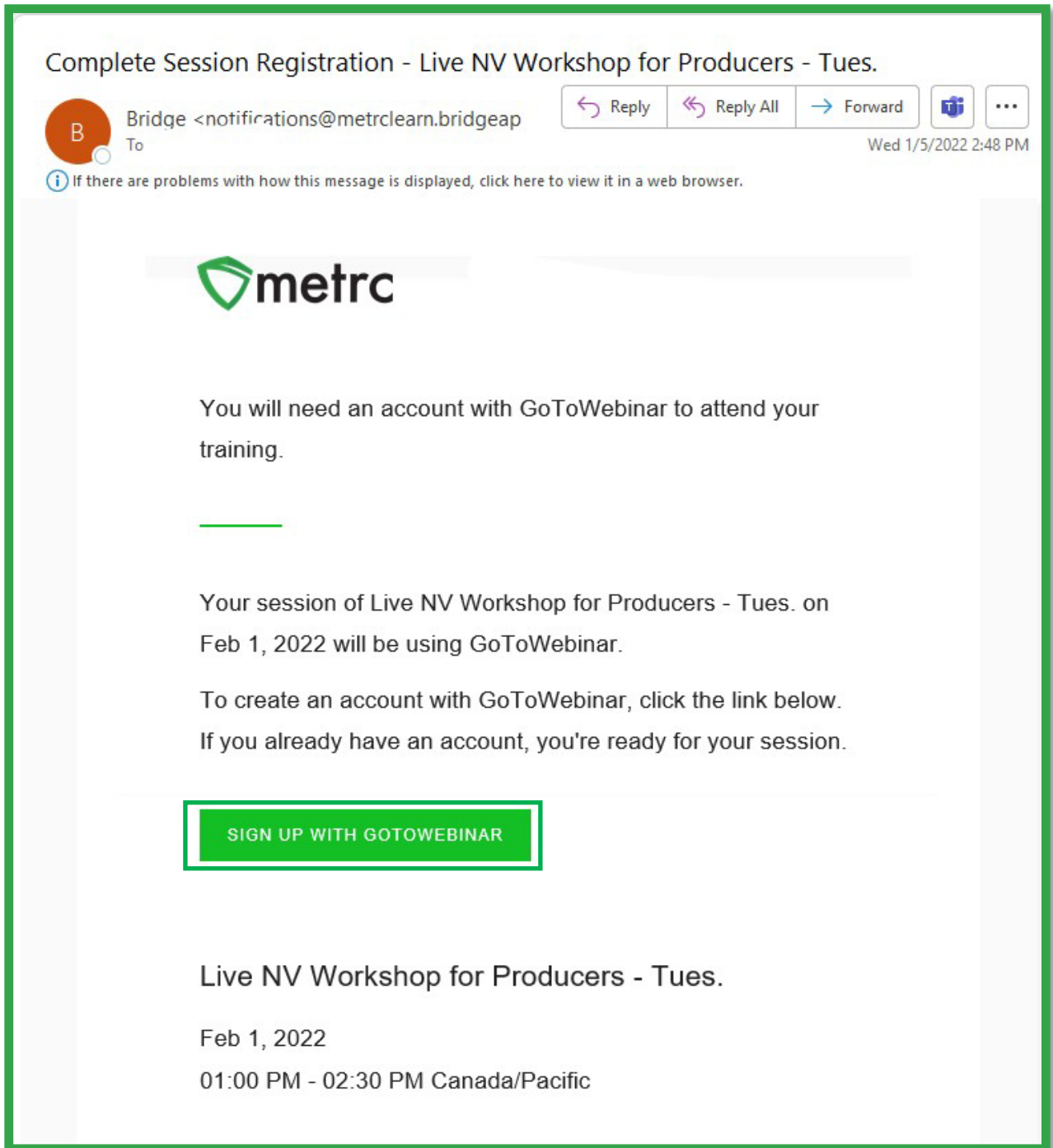



Figure 4: Register for “NV February Workshops 2023” from e-mail prompt
