New Item Category

An Item Category for "Topical" has been added to Metrc. **Topical sales to medical patients in Mississippi will not count against their daily allotment.** If a topical is sold to a non-patient, enter "N/A" in the field requiring a Patient Number.

Please contact MSDH for assistance with correcting any topical items already existing with a category of "Infused Non-Edible" via <u>mclicensing@msdh.ms.gov</u> or via your MSDH Medical Cannabis district assignee.

To create a new Topical item, navigate to the Items grid found under the Admin menu in the navigational toolbar at the top of the screen. Select the Add Items button as shown in **Figure 1**.

This will open the Add Items action window in order to create the new item. Enter the Item Name of the topical product being created. Then use the dropdown to select the Topical category. When creating this item, enter the Unit CBD & THC Percent (required), in addition to the unit weight as shown in **Figure 2**.

Once all of the information has been verified to be accurate for the item being created, select the "Create Items" green button to create the item. After all the items utilizing the new item category have been created, then discontinue any items that were previously categorized under the Infused Non-Edible Item Category. Doing this is important because using the Topicals categorized as Infused Non-Edibles can cause calculation issues with Patient Limits.

To discontinue an item, use the discontinue button on the far right side of the item needing to be discontinued as shown in **Figure 3.**
