Topic: Plant Group virtual training and updates on tag orders/tag order functionality.		

Greetings,

In accordance with instructions from the Office of Cannabis Policy (OCP), Metrc will be releasing new functionality to support the general availability of “Flexible Standardized Batch Tracking” (FSBT) for Maine’s adult use cannabis cultivators, which goes into effect in September 2023.

New functionality will only be relevant for Metrc users in Maine who choose to operate under the new FSBT guidelines and will require a change to users’ standard operating procedures as it relates to Metrc, including procurement of the proper quantity of RFID-enabled plant tags and using the proper Metrc system functionality to remain compliant with OCP regulations.

To support industry preparedness, the following resources will be provided by Metrc, including several Metrc Learn training opportunities. The rollout of new functionality is planned as follows:

Flexible Standardized Batch Tracking (FSBT)

The FSBT system that will be available in September 2023 will offer Maine’s adult-use cultivators the option to use fewer, standardized plant group tags alongside individual plant tags to enhance flexibility within the Metrc system while maintaining compliance.

Important notes:

- Plant Groups are defined as groups of cannabis plants at the same growth stage, location, and strain moving together as a group.
- Metrc documentation will refer to tags used in Maine’s FSBT system as Plant Groups.

Beginning in September 2023, plants can be tracked in the following ways:

- Cannabis Plant 1 QTY (current option)
- Cannabis Plant 5 QTY
- Cannabis Plant 10 QTY
- Cannabis Plant 25 QTY
- Cannabis Plant 50 QTY
- Use of multiple plant group tags
- Use of different and/or multiple plant group tags and/or individual plant tags

Cultivators will not be required to have 50 plants to be eligible to use a 50-count plant group tag, however, data captured in the Metrc system must be accurate. Users will be required to note various data inputs, such as which tags (plant group and/or individual) were used, how many tags were used, and the total number of plants being cultivated under each plant group tag.

Example: If a harvest includes 48 plants, a “50” plant group tag may be used, and “48 plants” should be entered into Metrc for that specific “50” plant group tag.

Both individual and plant group tags will be available for purchase for all Maine adult-use licensed cultivators as of August 21, 2023. While neither option offers inherent advantages for larger operators over smaller operators, and current monthly Metrc access fees and plant tag costs will remain the same regardless of choice, each licensed operation must determine which option best suits their operational needs while maintaining continued compliance with OCP regulations and protection of consumers’ health and safety.

Ordering RFID-Enabled Plant Tags

The process for ordering tags for plant tracking will remain the same for all Maine adult-use licensed cultivators who use Metrc. However, new order options will be made available beginning August 21, 2023. - **See Figure 1**

For all tag order options, the cost per tag, regardless of tag type, remains equal and is based on total number of tracked plants.

- Cannabis Plant 1 QTY will have a 1-plant maximum: \$0.45 per tag
- Cannabis Plant 5 QTY will have a 5-plant maximum: \$2.25 per tag (or \$0.45 x 5)
- Cannabis Plant 10 QTY will have a 10-plant maximum: \$4.50 per tag (or \$0.45 x 10)
- Cannabis Plant 25 QTY will have a 25-plant maximum: \$11.25 per tag (or \$0.45 x 25)
- Cannabis Plant 50 QTY will have a 50-plant maximum: \$22.50 per tag (or \$0.45 x 50)

While all Metrc RFID-enabled plant tags arrive compliance-ready, an important difference to note is tag color.

- When tracking plants individually, plant tags remain blue in color.
- When tracking plants in groups, plant tags will be orange in color, and include the clearly printed plant group count for identification purposes – **see Figure 2**

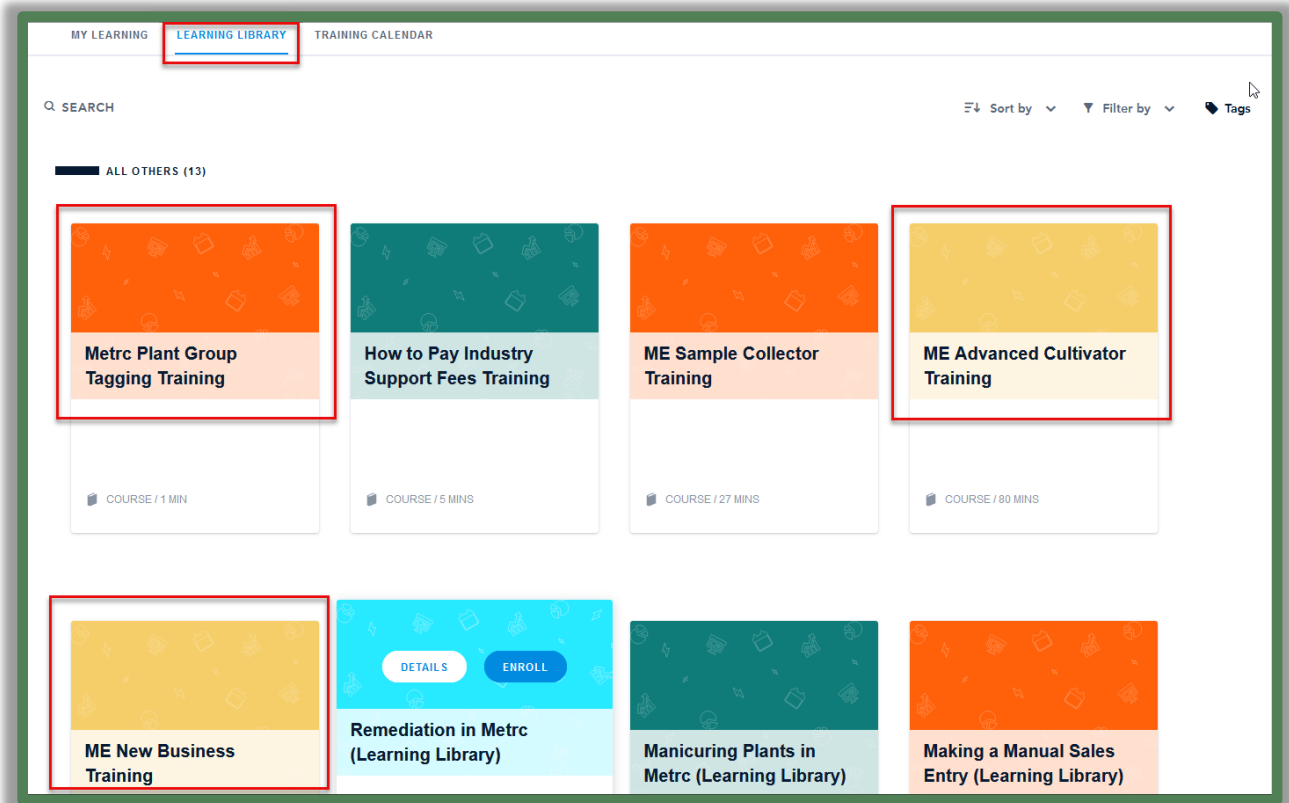


Figure 3: Access on-demand training in the Learning Library

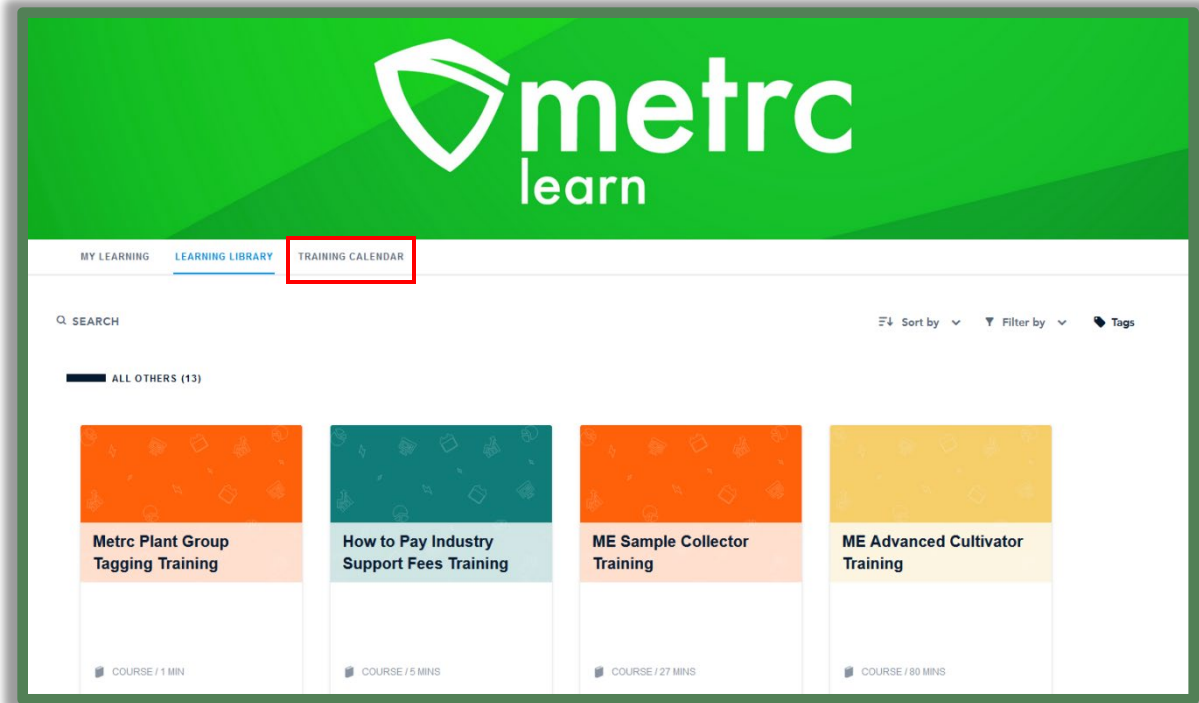


Figure 4: Access live training sessions in the Training Calendar

- Select the preferred ME live training – see **Figures 4 and 5**

 - **Note:** If working in multiple licenses, enter all licenses on the lines provided, and then select the license type that reflects the area of the role requesting access to Metrc training.

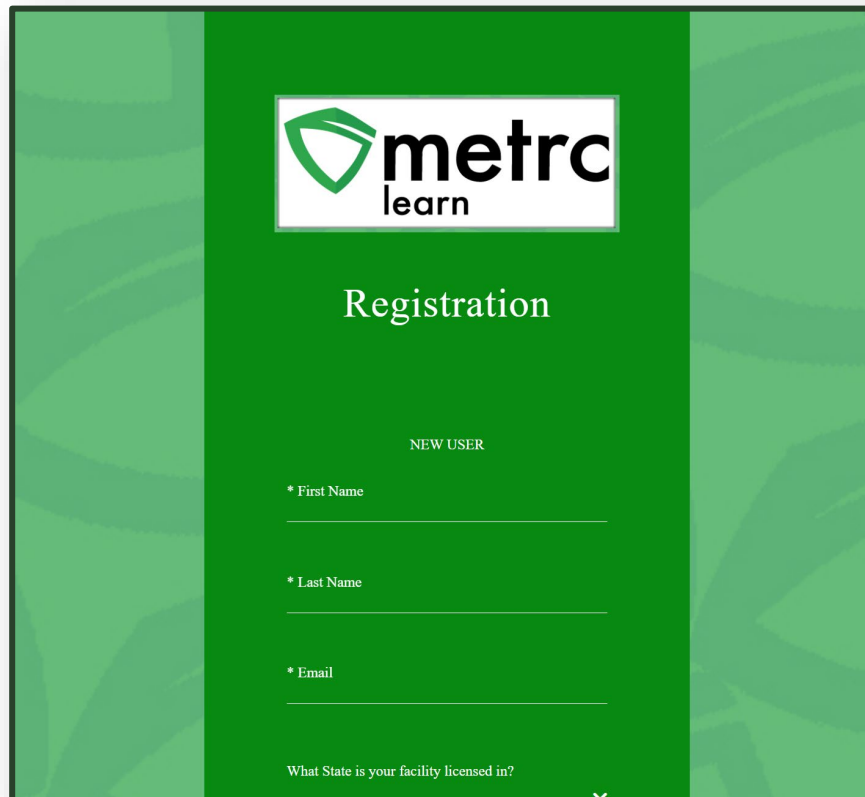


Figure 6: Metrc Learn Registration Page

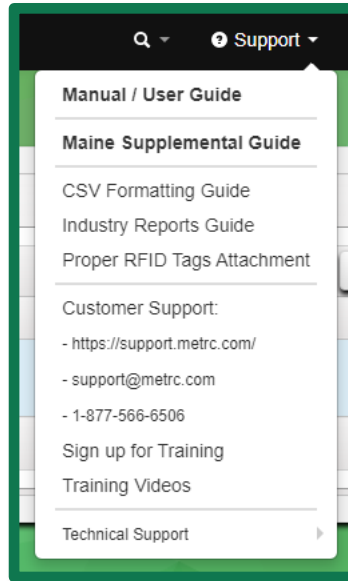


Figure 5: Metrc system – Access additional resources and/or Metrc Support
