 - Once registered for Metrc Learn, you can then register for the Industry User Group though the Metrc Learning Management System.
- Licensees are welcome to attend either in person or virtually a link to attend will be sent after registration is completed.

Register for Metrc Learn – An Interactive Learning Management System

Metrc Learn is designed to provide users with skills on the functionality available within Metrc they need to use the system effectively similar to the New Business and Advanced Facility Specific Trainings. Metrc Learn is organized into facility-specific journeys that contain various programs and courses. For example, the Cultivator program might include specific courses, such as "Creating an Immature Plant Batch," "Tracking Additives," and "Reporting Waste".

To register for Metrc Learn, please take the following steps:

- Navigate to the Metrc Learning Registration link see Figure 1.
- Enter the required information. Please enter the "Agent Registration Number" in place of the "Facility License Number".
 - **Note:** Users are encouraged to use an email they will have access to regardless of business association for their registration to ensure that any training transcripts are still accessible if email access is no longer available.
- Click on the 'Create Account' button to submit registration for Metrc approval.
 - **Note:** Please allow up to 48 hours (Monday Friday) for registration approval to be granted.

Upon approval of active Metrc Learn status, an email invitation will be sent to the email provided to set a password. **Note:** If working in multiple licenses, enter all licenses on the lines provided, and then select the license type that reflects the area of the role requesting access to Metrc training.
