Greetings Metrc Users,

Metrc, in conjunction with the Louisiana Department of Agriculture and Forestry (LDAF), is providing guidance on what is required within the notes area when utilizing package adjustments for waste. This guidance will supersede the guidance offered in Metrc Bulletin #8 released November 24th, 2019. Currently, the notes area is required, but additional requirements will need to be included in the notes field when recording waste for a package to ensure full transparency reporting to the LDAF.

Package Adjustments for Waste Notes

When a package has been identified that includes material that will be wasted out, highlight the package and select Adjust.

Selecting "Adjust" will prompt an action window where the amount of product that is being removed from the package will be indicated. Additionally, the reason for the adjustment will need to be added. In this case, it will be "Waste". This selection will require a freeform note to be submitted with the adjustment in the notes field.

The LDAF and Metrc are providing notice that going forward in this note field, the following should be recorded:

- Reason for waste
- Destruction method
- Material mixed with the waste to render it unusable
- The employee who physically destroyed the waste
- Date of physical destruction
