Reason: To notify dispensaries of changes to the Tribal and visiting Medical Patient sales process.		

Greetings,

Metrc, in conjunction with the Minnesota Office of Cannabis Management, would like to notify licensees of changes to the way that sales should be recorded for medical Tribal and visiting medical program patients. This applies to patient sales only, not adult-use sales.

Please read on for more information.



Recording Sales for Tribal and Visiting Medical Program Patients




Figure 1: External Patient Customer Type

Recent Minnesota law now allows for sales to visiting medical program patients. To record a sale from a Tribal or visiting medical program patient, a dispensary agent will select the "External Patient" sales type as normal – **see Figure 1**.

Within the "Patient No." field, please use the following formats:

Sales to Minnesota Tribal Patient Program Participants

For Tribal Patient Programs within Minnesota, use "PatientFirstNamePatientLastName-TRIBALABBR," such as below:

White Earth Nation: "JohnDoe–WEN" Red Lake Nation: "JaneDoe–RLN"




Figure 2: In State Tribal Patient

Please note that there should be no spaces within the "Patient No." field and that the "Ident. Method" field is required so "Minnesota" should be entered – **see Figure 2 below**. See the bottom of the bulletin for a full list of Minnesota Tribal abbreviations.

Sales to Tribal Patient Program Participants from outside of Minnesota

For sales to Tribal Patient Program Participants outside of Minnesota, use "PatientFirstNamePatientLastName-TRB," such as "JohnDoe-TBR."




Figure 3: Out of State Tribal Patient

Please note that there should be no spaces within the "Patient No." field and that the "Ident. Method" field is required, so the state where the Tribal Medical Program is located should be entered with the state name spelled out fully – **see Figure 3**.

Sales to Visiting Patients

For visiting patients from another state, district, commonwealth, or territory of the United States, use the patient name followed by "-OUT": "JohnDoe-OUT."




Figure 4: Out of State Medical Patient

Please note that there should be no spaces within the "Patient No." field and that the "Ident. Method" field is required so the state, district, commonwealth, or territory of the United States is required – **see Figure 4**.
