<b>Reason:</b> Metrc provides guidance on three areas of focus: item categories and related lab test batch requirements, transfer types, and preroll items.		

Greetings,

Metrc, in conjunction with the Virginia Cannabis Control Authority (CCA), are pleased to provide guidance on four areas of focus:

## 1) Item Chart

The CCA and Metrc have constructed an item chart that lists the required testing for the available Item Categories in the Metrc software.

## 2) Transfer Types

Available transfer types and use cases for each.

## 3) Prerolls and Infused Flower Apply to Patient Flower Limit

Raw Prerolls, Infused Prerolls, and Infused Flower item categories will pull from patient allotments for flower in Metrc.

## 4) Infused Flower (Bulk) & Raw Plant Material (Bulk)

As of **Monday 8/4/2025**, the following new item categories and lab test batches will be available in Virginia Metrc.

- Lab Test Batch for "Raw Plant Material – Bulk"
- New Item Category and Lab Test Batch for "Infused Flower (Bulk)"
- New Item Category and Lab Test Batch for "Infused Flower (Each)"

## Transfer Types

There are several transfer types available in Metrc for licensees to document the movements of cannabis items. These transfer types are specific to Virginia Metrc and are determined by the CCA.

**Note:** When transferring packages within a colocated facility, licensees may use the **Integrated Facility Transfer** type.

Below is a guide on the available transfer types in Metrc:

Transfer Type	Require Transporter Info?	Use Case
Beginning Inventory	NO	ONLY for use during Beginning Inventory period
Hemp Extract Incoming	NO	Transfer in hemp extract for use in processing jobs
Testing Facility Transfer	YES	Transfer samples to testing facility for lab testing
Unaffiliated Transfer	YES	Transfer items between two unaffiliated facilities
Affiliated Transfer	YES	Transfer items between two affiliated facilities
Integrated Facility Transfer	NO	Transfer cannabis within a colocated (integrated) facility

## Prerolls and Infused Flower Apply to Patient Flower Limit

Please note that items in the following item categories now apply to Patient Flower Limits when a patient sale is registered:

- Raw Prerolls
- Infused Prerolls
- Infused Flower (Each)

## Infused Flower (Bulk) & Raw Plant Material (Bulk)

Please note that as of **Monday 8/4/2025**, there will be new item categories and associated lab test batches for “Infused Flower (Each)” and “Infused Flower (Bulk)”.

There is also a new Lab Test Batch for Raw Plant Material (Bulk) available beginning on **Monday 8/4/2025**.
