#### Greetings,

Metrc and the DCC are pleased to announce the release of additional Administrative Recall functionality in Metrc effective August 18, 2025.

This bulletin provides important information related to identifying packages with a recall status and to highlight relevant updates associated with packages that carry this designation.

It also highlights new direct-to-consumer alerts through Metrc Retail ID.

# **Administrative Recall functionality**

The Administrative Recall functionality is designed to provide additional transparency for Metrc users regarding the status of a package within their facility's inventory. There are several ways in which users may identify that a package has been placed on Administrative Recall.

When a package is designated with the recalled status, the Metrc Account Manager and Owner(s) of the facility will receive an email notification of the administrative recall. The email will provide the UID number and the item name of the product that has been recalled.




Figure 1: Identifying Packages Designated with Administrative Recall

Metrc Users who do not receive the email notification can identify recalled packages on the Packages Grid – **see Figure 1**.

- The package information will be displayed in blue.
- The Administrative Recall (A.R.) column will display as "Yes" with a blue rectangle highlighting the text.
- A banner will display notifying users that a package has been designated with the recalled status.

**Important note**: Packages under administrative recall cannot be combined, repackaged or submitted for additional lab testing. The system will allow users to transfer packages



marked with this status, but please refer to instructions received from DCC on the allowable movement of products designated with this status.

# **Product Recall Alerts with Metrc Retail ID**

For California licensees, Metrc Retail ID now offers a way for consumers to verify if a product with Retail ID applied has been recalled.

The new administrative recall functionality integrates with Metrc's latest optional solution, Metrc Retail ID. When a consumer scans the Metrc Retail ID QR code of a product that has an administrative recall status, a mobile applet launches (Metrc VerifID), displaying the product card along with the recall notification at the top.




Figure 2. Product recall notification via Metrc VerifID application

As shown in **Figure 2**, this alert can also include a health advisory link provided by the California Department of Cannabis Control (DCC) for additional guidance on the respective recall.
