Reason: Refresher on the recent updates to the definition of MMCEU to ensure compliant sales are recorded in Metrc or Third Party Point of Sale systems.		

Greetings,

As a refresher we would like to provide information on the changes included with House Bill 611. Changes to cannabis concentrate and infused products are listed below.

- 210 (ii) One (1) gram of THC in a medical cannabis concentrate; or
- 212 (iii) One * * * (1) gram of THC in an infused product.

Please read on for more information regarding these changes.

For all Concentrate-type items, the conversion from Weight sold to THC sold is automatically made in Metrc based on the Unit THC value associated with a given item. The licenses that produce these products have assigned those Unit THC values in Metrc as a reflection of the quantity of THC in one gram of product.

To ensure that all sales are accurately recorded in Metrc and reflected against patient allotments, it is critical to properly configure these products in your Point of Sale (POS) system if you are not reporting sales directly in Metrc.

Important: Please work with your POS provider to ensure that your system is configured to report sales to Metrc by weight of product sold, not weight of THC sold, as the THC conversion occurs in Metrc at the time of sale.

Examples:

Conc. Infused Pre-Rolls	Metrc Caviar Pre-Rolls	450mg	1.3 grams	1.3 grams	0.0206oz (equivalent to 585mg, the amount of THC in 1.3) grams of product)
Infused Flower	Metrc Moon Rocks	500mg	2 grams	2 grams	0.0353oz (equivalent to 1,000mg, the amount of THC in 2) grams of product)
Concentrate(each)	Disposable Vape 1g	600mg	1 gram	1ea	0.0212oz(equivalent to the total 600mg THC in the product)
Concentrate(each)	Disposable Vape 0.5g	300mg	0.5 grams	1ea	0.0212oz(equivalent to the total 300mg THC in the product)
