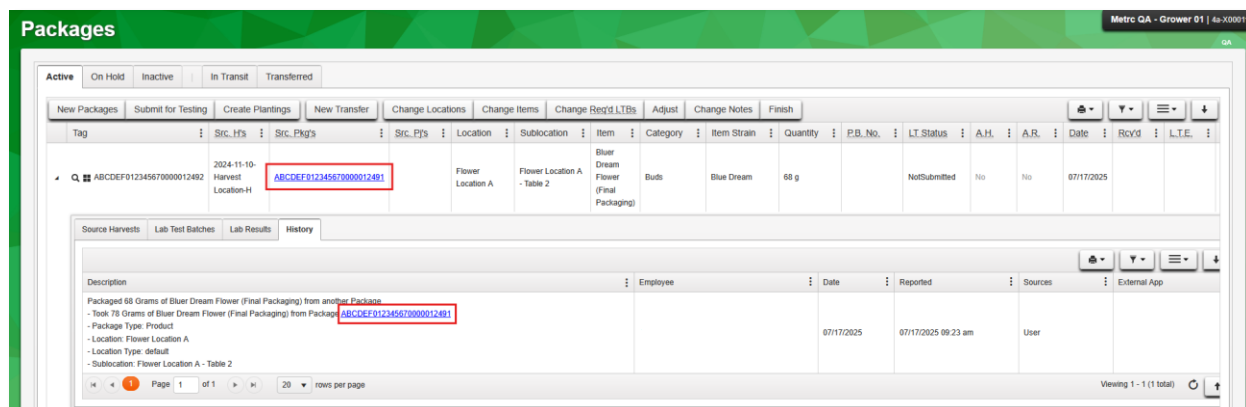

Reason: Announcing a new feature providing clickable package and transfer manifest hyperlinks.		

Greetings,

We are excited to announce a new feature, clickable links for Packages and Transfer Manifests. This feature will eliminate the need for manual searches by turning key references—like package IDs and manifest IDs—into direct access points.

This feature saves time in searching for Packages and Transfers which streamlines traceability and provides users with faster insights through more efficient navigation in the system.



Streamlined navigation with smart hyperlinks

Now, when you click a hyperlink, a new tab will open displaying the tag in its most up-to-date location, right where you have access to view it.

- **Multiple License access?** You'll be taken directly to the active license where the item is located.
- **Single License access?** You'll land on the *Transferred* tab, showing exactly where the tag currently resides.
