Reason: To announce the availability of a new Metrc Industry Sandbox for licensees to use to explore, train, and experiment with the Metrc system risk-free.		

Greetings,

We are pleased to announce that a secure, simulated training system – Metrc Industry Sandbox – will be available in Metrc on the evening of October 6th.

Developed in response to user feedback, the Metrc Industry Sandbox is a risk-free solution that closely mirrors the main Metrc system, allowing you to:

- **Practice without pressure:** Safe for mistakes — you can confidently practice, test workflows, experiment with different scenarios, navigate system features, and explore functionality without any real-world consequences.
- **Train more effectively:** Ideal for onboarding and training — Learn in a realistic environment with sample demo data, so nothing is permanent.
- **Enjoy streamlined access:** Easy setup and access through the main Metrc system.
- **Know you're in a safe testing environment:** Clear distinctions and alerts prevent confusion between the sandbox and the main Metrc system.
- **Experiment more:** Access license types and permissions that may not be available in the main Metrc system, enabling more comprehensive testing and learning opportunities.

The Metrc Industry Sandbox is pre-configured to reflect state-specific Metrc system settings and will use demo data so you can experiment with core system features.

Accessing Metrc Industry Sandbox

Active credentials for the main Metrc system are required to access the Metrc Industry Sandbox. Once logged in to the Metrc system:

- Navigate to Metrc Support section from the navigation menu.

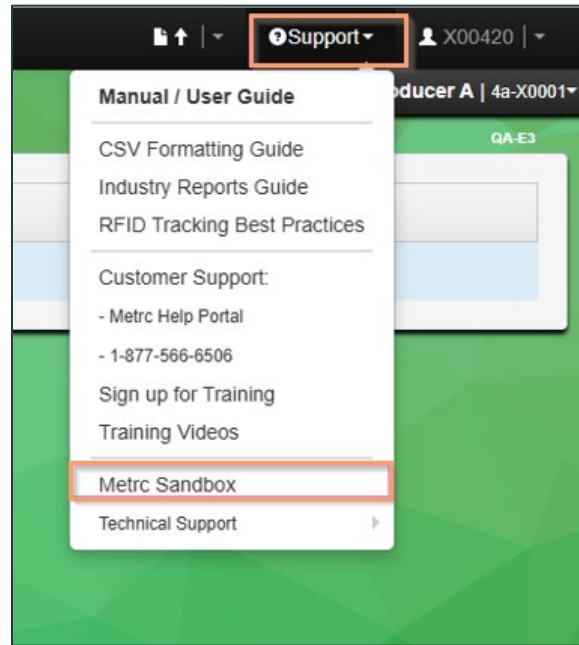


Figure 1: Accessing Metrc Industry Sandbox

- Select Metrc Sandbox from the dropdown options – **see Figure 1.**

- A setup notification pop-up window will appear. Enter the email address associated with your Metrc account to initiate the setup process. This email entry is required for both initial setup and after any future system resets – **see Figure 2.**

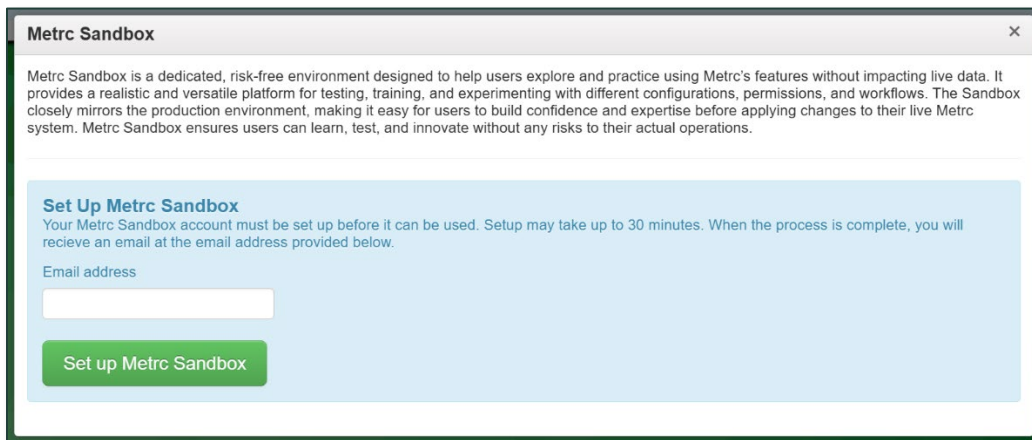

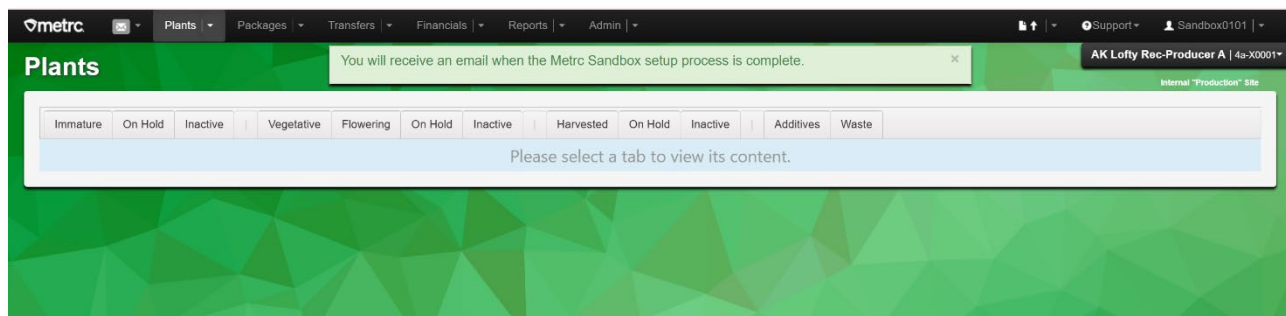


Figure 3: Confirmation banner for Metrc Industry Sandbox setup initiation

- After entering your Metrc account email address, click “Set up Metrc Sandbox” to submit the setup request. This action will begin the sandbox environment preparation. After submitting your setup request, a confirmation banner will appear to notify you that the setup process is underway – **see Figure 3**.

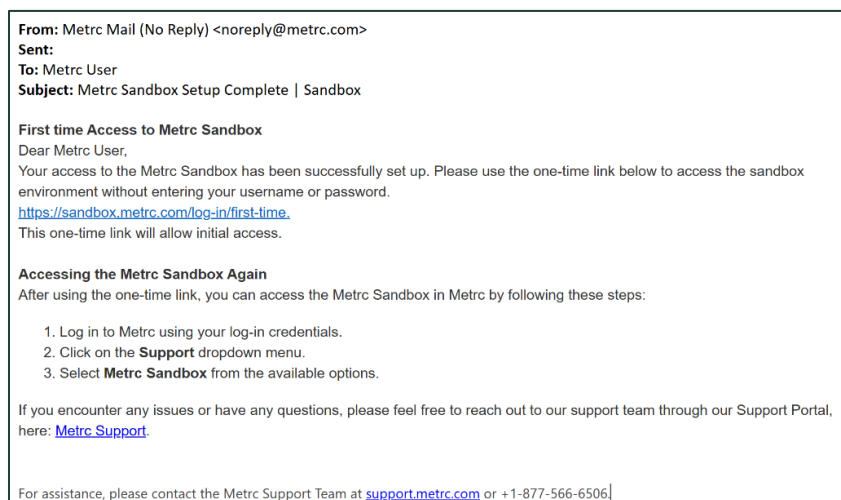


Figure 4: Metrc Industry Sandbox setup notification email

- The system will begin preparing your access to the Metrc Industry Sandbox. Then, an email will be sent to the email you input into the setup action window once the sandbox is ready. This usually takes between 5–15 minutes – **see Figure 4**.

- Monitor your email inbox for the Metrc Industry Sandbox setup notification email. The email will contain a direct access link.
 - **Note:** The email link will include an expiration date. Make sure to click the link to access the sandbox before the link expires.
- Click on the link in the notification email. This will automatically redirect you to the Metrc Industry Sandbox without requiring additional navigation.

- Once the link takes you to the Metrc Industry Sandbox, you'll be presented with a user agreement. Review and accept this agreement to proceed with access.

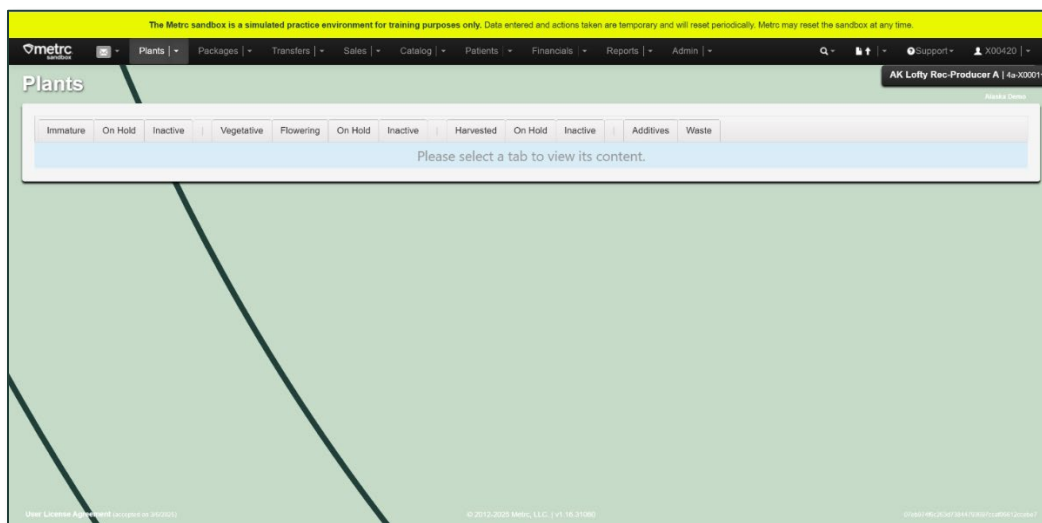


Figure 5: Metrc Industry Sandbox

- After accepting the user agreement, you will be automatically logged into the Metrc Industry Sandbox and can begin using it immediately – **see Figure 5.**

Important reminders:

- You must use the email address associated with your Metrc account for setup. This same email entry and link process applies to both initial setup and any future sandbox resets.
- The setup process typically takes 5–15 minutes from initiation to email delivery.
- The email link provides direct, secure access without additional login steps.
- Always check the expiration date on email links before attempting access.

After using the one-time link, you can access the Metrc Sandbox in Metrc by following these steps:

- Log in to Metrc using your log-in credentials.
- Click on the Support dropdown menu.
- Select Metrc Sandbox from the available options.

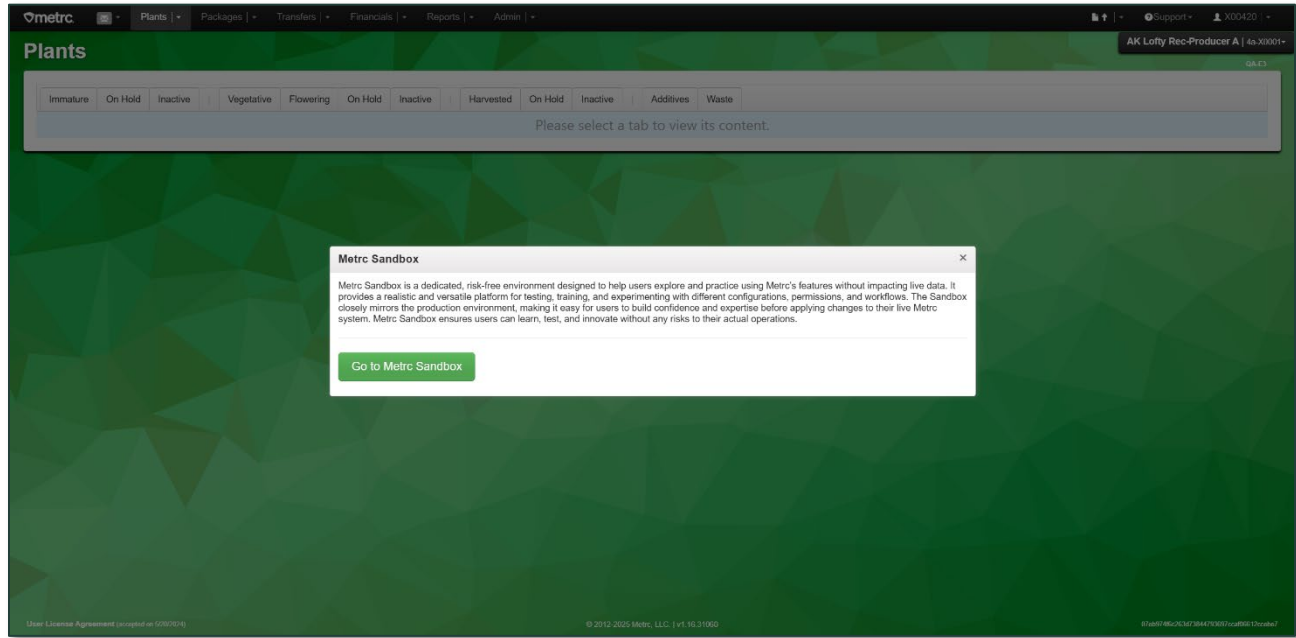


Figure 6: Exit main Metrc system and access Metrc Industry Sandbox notification

- Click the “Go to Metrc Sandbox” button on the pop-up window – **see Figure 6.**

To exit the Metrc Industry Sandbox and return to the main Metrc system, simply exit out of the window, or you will be logged out automatically after the timeout duration has been reached.

Important Metrc Industry Sandbox information

With the Metrc Industry Sandbox, you are free to explore different features and workflows risk-free while accessing various license types and permissions; however, some features may not be fully functional.

Data, acknowledgment reminder and notifications

The Metrc Industry Sandbox will mirror your main Metrc system permissions, but with demo data instead of live compliance reporting data.

- Demo data will be periodically reset on a quarterly basis, with historical data being cleared during each reset.
- A notification banner will always display above the Metrc navigational toolbar that will read:

“The Metrc sandbox is a simulated practice environment for training purposes only. Data entered and actions taken are temporary and will reset periodically. Metrc may reset the sandbox at any time. The next reset is currently planned for MM/DD/YYYY.”

These reminders are intended to notify you of upcoming resets and reinforce that actions taken are temporary and will not affect compliance reporting data.

User Profiles

Metrc Industry Sandbox users will not see password or security question fields in their profile; however, users can still update the preferred default facility to practice in.
