Greetings,

Metrc, in conjunction with the New Jersey Cannabis Regulatory Commission (CRC) are pleased to provide information about a new item category titled “Raw Pre-Rolls (each)” that will be available in Metrc starting on December 15, 2025.

Please read on for details.

New Item Category: Raw Pre-Rolls (each)

On December 15, 2025 a new Item Category “Raw Pre-Rolls (each)” will be available for Adult Use and Medical Manufacturers and Cultivators in New Jersey to use when creating raw pre-rolls. This item category is count-based with a unit of measure of “each”.

The purpose of this item category is to classify raw pre-rolls that are packaged for retail sales.

NOTE: This item category should be used for RAW pre-rolls only, NOT infused pre-rolls (refer to guidance in [NJ Industry Bulletin #38](#)).

New items created using the Raw Pre-Roll (each) item category do not require pre-approval by the NJ CRC. Unit weight is a required field when creating items in this category. Unit weight is the weight of the cannabis products within one packaged unit.

Here are some use cases for the Raw Pre-Roll (each) item category:

- **Single pack unit**
 - A plastic tube (unit) containing one 2-gram raw pre-roll has a unit weight of 2g. The individual unit is documented as one each in the system.
 - Patient sale: 2 grams of flower is deducted from allotment.
- **Multi-pack unit**
 - A mylar bag (unit) containing two 1-gram raw pre-rolls has a unit weight of 2g. The individual unit is documented as one each in the system.
 - Patient sale: 2 grams of flower is deducted from allotment.

To use the Raw Pre-Roll (each) Item Category, a new Item will need to be created. For guidance on how to create a new item, please reference the knowledge base in Metrc Expert.

- To access Metrc Expert, log in to Metrc and look for the white circle with the green shield icon in the bottom right corner.
