

Reason: To announce a new feature that notifies users that a different item category was selected when creating a test sample.		

Greetings,

Metric users will now notice that an error is triggered when creating a test sample using an item that is different from the source package. For example, if creating a test sample from a package with an item category of “Bulk Flower/Buds” and an item with the category of “Raw Single Serving Unit” is select for that test sample, a red error box will appear, as seen below. It is recommended that the “Same Item” checkbox be used when creating test samples in Metric. This issue is designed to limit mistakes made during the sample creation process.
