<b>Reason:</b> Provide the ability to add a vehicle's registration number to vehicle records.		

We're excited to announce a new enhancement to vehicle management in Metrc designed to support transporter compliance.

Transporters can now add a vehicle's registration number directly to vehicle records in Metrc. The **Registration Number** field supports multiple state-required vehicle identifiers, such as registration numbers, certification numbers, or VINs, allowing transporters to meet varying state compliance requirements.

In addition to existing make and model fields, this new data point allows licensees to reflect vehicle information and improve transparency with regulators more accurately.

**Why this matters:**

- Improves data accuracy and audit readiness
- Eliminates the need for external tracking or workarounds

This update ensures Metrc continues to evolve alongside state regulations—providing transporters with a single, trusted system to manage compliant vehicle operations.

The new field is available immediately when adding or updating vehicles in Metrc.

**Vehicle Registration Number**

Licensed users will need to be granted permission to manage Transporters to add a Vehicle's Registration Number.

The registration number is an optional field that allows up to 100 alphanumeric values and can only be associated with one active vehicle - **see Figures 1 & 2 below.**

## Transfers

For any type of transfer (Licensed or External) when using a transfer type that is configured to capture Transporter Information, the “Registration Number” field will display in the action window along with the rest of the transporter's vehicle information. Depending on the state requirements, this field might be required. The **Registration Number** field supports multiple state-required vehicle identifiers, such as registration numbers, certification numbers, or VINs, allowing transporters to meet varying state compliance requirements – see **Figure 3**.
