Reason: To announce the availability of trade sample functionality within Metrc.		

Greetings,

Metrc, in conjunction with the OCM, is pleased to provide information on an update that will allow industry users to create Trade Samples with Adult-Use licenses. Trade Samples are samples created by license holders and provided to other licenses, and/or employees. This bulletin provides information on the process license holders will need to follow to designate packages as a trade sample.

Please note, trade samples are not to be sold for any dollar amount and are for the strict purpose of allowing other licenses to test new products. Trade samples are available for Adult-Use licenses only.

Designating a Trade Sample

Trade samples should only be created/used for packages that are intended as samples for other licenses to try the product. Trade samples cannot be sold to an end consumer, nor can they be unmarked as a trade sample once they have been transferred. Because of this, it is very important that a package that is, in fact, not a trade sample that it not be transferred or accepted on a manifest.

A package can be created as a trade sample from within the New Packages action window by selecting the “Trade Sample” checkbox below the package date field – **see Figure 1.**

Once a package has been created as a trade sample, that package will display an icon in the shape of a briefcase. This allows for easy identification of trade samples on transfer manifests and within the packages grid – **see Figure 2.**

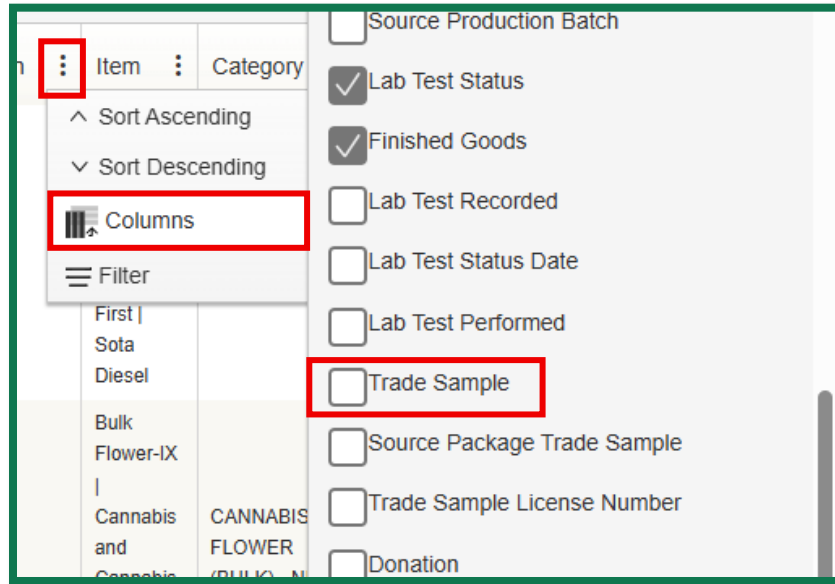


Figure 3: Adding a Trade Sample Column to the Package Grid

The columns within the package grid can also be adjusted to include a Trade Sample column by clicking on the three vertical dots to the right of any column, navigating to “Column” and selecting the “Trade Sample” checkbox – **see Figure 3 below.**

Flagging/Unflagging Trade Samples for Existing Packages

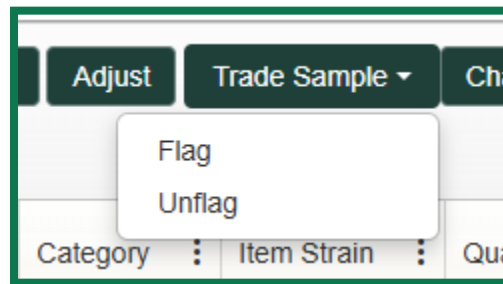


Figure 4: Flag/Unflag Trade Samples in Packages grid

If a package is made, prior to being transferred, and is found to need to be identified as a trade sample (or have that designation removed), it can be marked or unmarked as such using the “Trade Sample” button within the packages grid – see Figure 4.

It is important to again note that once the package has been transferred, the designation of trade sample cannot be undone.

Adjusting a Trade Sample

Once a trade sample has been received and used, the trade sample package will need to be adjusted down to zero using the “Employee Sample” adjustment reason and a note of the employee that sampled the product – see Figure 5.
