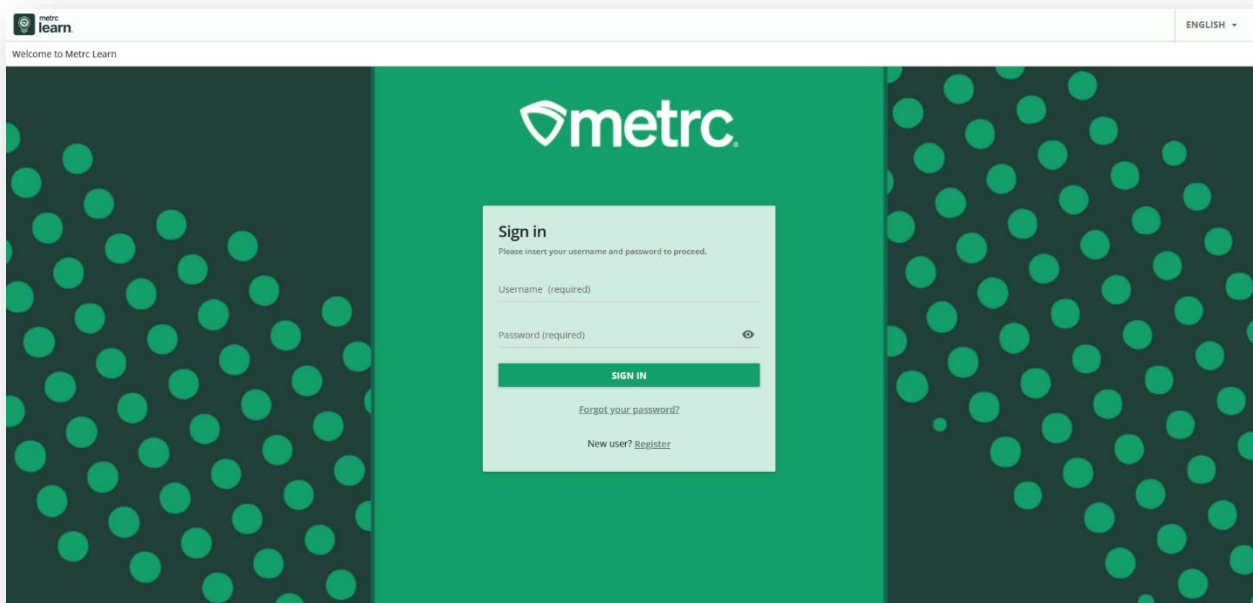
- All licensees attending the Virtual Industry Webinar must first be registered for [Metrc Learn](#), learning management system (detailed steps below).

## Register for Metrc Learn

Metrc Learn is the learning management system for Metrc. To register for a Metrc Learn account, take the following steps:


1. Navigate to the Metrc Learn login page by:
  - Using the new link: [learn.metrc.com](https://learn.metrc.com); or
  - From within the Metrc system – Navigate to the Support area dropdown on the navigational toolbar and select “Sign up for Training”.
2. Click the ‘Register’ link next to ‘New user?’ – **see Figure 1**.


