This document defines product set-up requirements expiration dates in Metrc.

Package Expiration or Use by Date

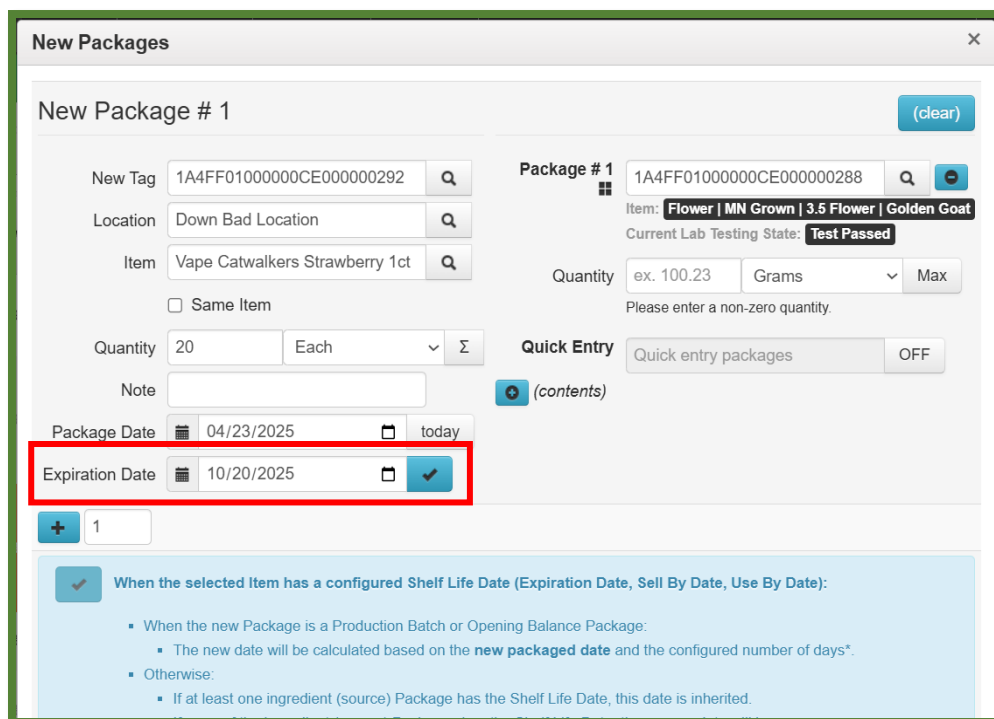
Effective September 2, 2026, all packages must have a listed expiration or best by date following the guidelines of (GM-2026-04). Minnesota Statute 342.02 Subd 2(4) indicates that flower must be assigned a 'best if used by' date, while Metrc has the field 'Use By.' These terms are considered interchangeable.

When creating a package for an item that requires an Expiration Date or Use By Date, users should review and manually update the Expiration Date field or Use By Date to align with COAs and compliance testing date. If the expiration date is not updated, it will default to 1 day.

"CANNABIS FLOWER (BULK)" and bulk forms of concentrations, distillates, and extracts have an optional expiration or use by date with a default of 365 days. The expiration or use by date will automatically populate but can be deleted.

Updating Package Expiration Date

The expiration or use by date can be updated manually when creating a new package using a new item. Please note that there will not be an expiration or use by date field when repackaging an existing package using the same item, as shown in **Figure 2**.

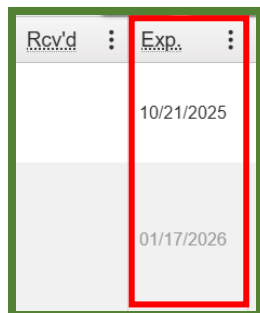
At the bottom, a blue box contains the following text:

When the selected Item has a configured Shelf Life Date (Expiration Date, Sell By Date, Use By Date):

- When the new Package is a Production Batch or Opening Balance Package:
 - The new date will be calculated based on the new packaged date and the configured number of days*.
- Otherwise:
 - If at least one ingredient (source) Package has the Shelf Life Date, this date is inherited.

Figure 2: Expiration Date Field in New Packages Window

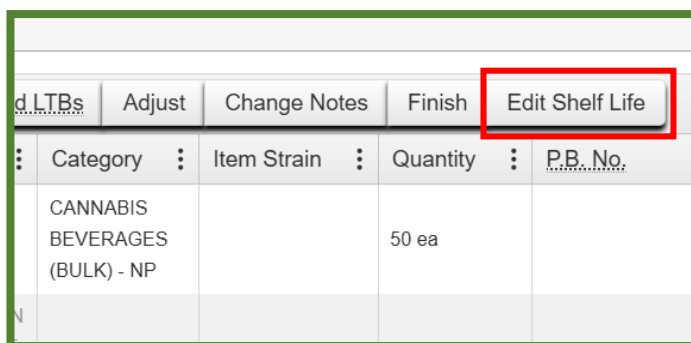
Once the new package has been created, that package will appear in the active packages grid. Notice that there is an expiration date column in the grid and the input expiration data appears in that column, **see Figure 3**.

Figure 3: Expiration Date Column on the Packages Grid

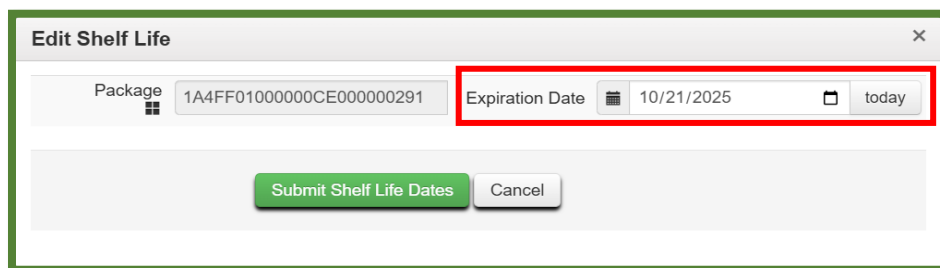
To update the expiration or use by date for a package, navigate to the packages area in Metrc on the navigational toolbar, select the desired package and click the “Edit Shelf Life” button to input an updated expiration or use by date **see Figure 4**. This update is applied only to the selected package. It does not apply to any child packages.

This will open the Edit Shelf Life action window to enter a new expiration or use by date, if needed, **see Figure 5**. Only the producer of the package should update the shelf life. The “Edit Self Life” feature will only be enabled for cultivation and manufacturing facilities.

Expiration or Use By Date Calculation

For all flower products, the license holder must enter a Use By date, and for all concentrates and finished products, a license holder must enter an Expiration date. When creating a new package, that expiration or use by date will automatically be set to 1 day either from the harvest date for bulk flower or from the packaging date. These dates can be manually updated at the package level.

Expiration or based by dates are calculated by adding the product stability to the date of the initial compliance testing. If there is not a product stability study completed, the expiration or best by date should be within 6-months of the compliance testing date.

It is the responsibility of the business that produced the package to define the expiration or use by dates and ensure compliance with all requirements and guidance. Product that has passed the expiration date on the physical label must be segregated and destroyed by the business. Wholesalers and Retailers will not be able to update self-life for packages in their inventory. For Minnesota expiration or use by date requirements, please refer to the Minnesota Rules, part 9810.3100 subpart 5F and Minnesota Cannabis Technical Authority.

Expiration or use-by dates should be based on the product stability established through stability testing. Based on the results of the stability test results, the expiration date or use by date can be calculated by adding the stability or shelf-life demonstrated to the date that compliance testing was successfully completed. For example, if 8-month stability is demonstrated for a product, and it was tested January 1st, the expiration date would be August 31st.
