Reason: Metrc is providing details for live, virtual industry user training classes.		

For all licensees and Metric users in the state of Nevada, we're excited to announce our upcoming virtual Metric Training Workshops in July 2026.

As of July 2026, Metric Training Workshops will be jointly presented by Metric and the Nevada CCB and will be conducted bi-annually. Please ensure that each user or attendee a [Metric Learn account](#) and register for the training workshops through Metric Learn.

In accordance with instructions from the CCB, the new Metric training requirements **for Metric users, or those who access the Metric system**, are as follows:

- Complete New Business Fundamentals (one time only).
- Complete Facility-Specific training (one time only).
- Complete Advanced Metric Training (annually).
 - Nevada Advanced Cultivator Metric Training
 - Nevada Advanced Processor Metric Training
 - Nevada Advanced Store Metric Training
 - Nevada Advanced Testing Facility
- After the initial online course has been completed, all subsequent annual Advance Metric Training requirements must be satisfied by attending additional training sessions, including virtual training workshops or in-person Metric User Exchanges events.

Additionally, **users who work in the facility but do not access the Metric system**, training requirements are as follows:

- Complete Facility-Specific Training (one time only)
 - Metric Training: Cultivation
 - Metric Training: Distribution/Transporter
 - Metric Training: Manufacturer/Processor
 - Metric Training: Retail/Sales
 - Metric Training: Testing Facility

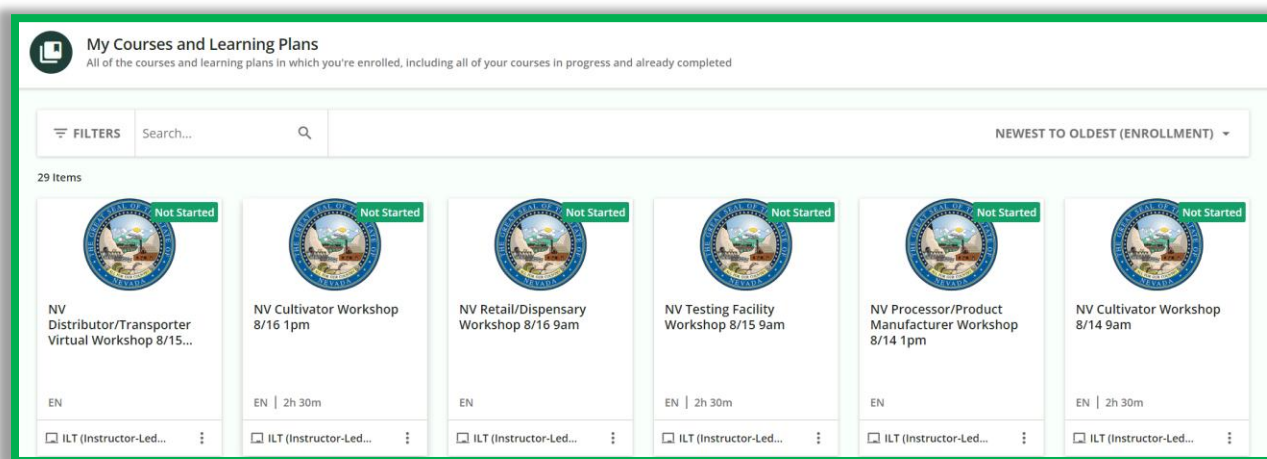


Figure 1: Available courses to choose a workshop in Metrc Learn account

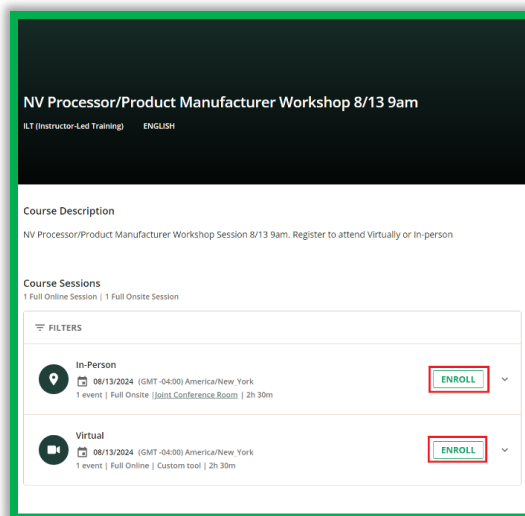


Figure 2: Enrolling for a specific workshop from a Metrc Learn account

Workshop Dates

July 27, 2026

Testing Facility Workshop 9:00 AM – 11:30 AM (Virtual)

Description: This training provides an overview of Nevada cannabis laboratory compliance requirements and regulatory expectations. Topics include recordkeeping, chain of custody, sample tracking and retention, Standard Operating Procedures (SOPs), quality assurance and quantity control procedures, security requirements, reporting analytical results, Certificates of Analysis, sample destruction, and operational compliance. The objective is to ensure laboratory personnel maintain accurate records, traceability, and regulatory compliance.

Transporter/Distributor Workshop 1:00 PM – 3:30 PM (Virtual)

Description: This training covers the requirements for compliant cannabis distribution operations. Topics include licensing, transportation requirements, insurance, vehicle inspections, manifests, inventory control, product security,

recordkeeping theft and diversion prevention, and public safety requirements. The objective is to ensure distributors understand regulatory obligations and best practices for secure transportation and inventory management.

July 28, 2026

Processor/Product Manufacturers Workshop Session 1
9:00 AM – 11:30 AM (Virtual)

Description: This training provides an overview of cannabis production compliance and operational requirements, including security, licensing, personnel training, Standard Operating Procedures (Sops), inventory management, and Metrc compliance. Topics include inventory intake, processing, manufacturing, packaging, transfers, testing requirements, product destruction, and common compliance violations. The objective is to ensure staff understand production workflows, inventory tracking, and regulatory requirements.

Retail/Dispensary/Consumption Lounges Workshop Session 1

Description: This workshop is for cannabis industry professionals managing product transfers and tax filings. Learn how to classify transfers like wholesale initial (affiliate and non-affiliate), Wholesale subsequent, and the requirements for temporary transfers. The session covers essential tax reporting practices, helping you stay compliant and avoid common mistakes.

Cultivator Workshop Session 1
10:30 AM – 1:00 PM (Virtual)

Description: This training covers the requirements for maintaining a compliant cannabis cultivation operation, including security, licensing, Standard Operating Procedures (Sops), plant tracking, inventory management, and Metrc compliance. Important reminders:

- All bi-annual training workshops will be hosted live and will be virtual. **These are required for Metrc system users only.** A Metrc Learn account, enrollment in and completion of the preferred session is also required.
- Metrc User Exchange event attendance is acceptable to fill the requirement **for Metrc system users only.** More information on the 2026 User Exchange will be shared once available.
- **For users who work in the facility but do not access the Metrc system,** one-time completion of Facility Specific Training is required.
